On 11-26-19 at 2010 hrs, I was dispatched to 10304 Forest Hill Blvd, Wellington, FL 33414 (Dillards) in reference to a shoplifting. The suspect was already in custody prior to me being dispatched.

I made contact with Loss Prevention Officer Jose Viracacha who stated that the suspect was observed on video surveillance camera walking into the sunglasses department and placed 4 pairs of sunglasses into a Dillards shopping bag. The suspect walked past all points of sale towards the Inner part of the Wellington Green Mall. The suspect was approached by security officers who stopped her outside of the entrance of Dillards. Inside of the Dillards shopping bag the 4 pairs of sunglasses were located as well as a pair of cold weather gloves and two jean jackets that had also not been paid for as well.

The suspect was trespassed from every Dillard's nationwide and was also trespassed from the Wellington Green Mall. The suspect was explained that if he returned to any Dillard's or to the Wellington Green Mall that he would be subject to arrest. The suspect verbally acknowledged the trespass warning.

The suspect was transported to the Palm Beach County Jail.
