(PROBABLE CAUSE STATEMENT)

On Tuesday, October 22 2019, at approximately 0138 hours (1:38 AM), I, D/S Stockwell #18352 was on patrol in a fully marked PBSO patrol vehicle while wearing a fully marked PBSO uniform. While on patrol, I observed a blue Hyundai Elantra (Florida License Plate BNU7U) pass me and was traveling above the posted speed limit of 40 miles per hour in the 1200 block of South Military Trail, West Palm Beach, FL 33415. I also observed heavy rear end damage to passenger side of the vehicle, as well as the passenger side mirror hanging down as if it was broken. At that time, I accelerated my patrol vehicle to 55 miles per hour to catch up to the Hyundai Elantra. At 55 miles per hour, the Hyundai Elantra was continuing to pull away from me.

At that time, I got behind the vehicle as it was making a right turn to travel westbound on Forest Hill Boulevard. I then informed PBSO Dispatch that I would be conducting a traffic stop on the Hyundai Elantra. I then activated the overhead emergency red and blue lights of my patrol vehicle signaling the driver to pull over. The driver of the Hyundai Elantra then made a left turn and stopped in the parking lot of El Bodegon Supermarket, located at 4704 Forest Hill Boulevard, West Palm Beach, FL 33415. I then approached the vehicle and made contact with the driver, and sole occupant of the vehicle, who was identified by her Florida Drivers License as Rossy Soto - Lira (W/F, 10/13/1987). Upon making contact with Soto - Lira, I could smell the scent of an unknown alcoholic substance emitting from her person, which would become stronger when she would speak. I also observed that her eyes were bloodshot and glassy.

Due to the possibility of Soto - Lira being under the influence of an unknown alcoholic substance, DUI Investigator Soloway #8586 responded to the scene to conduct a DUI investigation. Upon DUI Investigator Soloway's arrival, I informed him of my observations of Soto - Lira. At that time, DUI Investigator Soloway took over all investigative responsibilities and began conducting a DUI investigation.

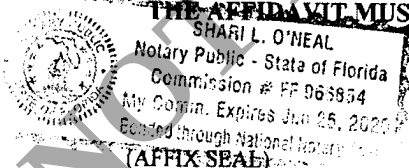
