


P R O B A B L E C A U S E	<p>On 10/30/16, at approximately 0233 hours, while on routine patrol of the 6000 block of W Glades Road, I observed a grey Lexus bearing Florida tag EDJI70 in the median of the main entrance to the Town Center Mall at 6000 W Glades Road. The Lexus was up and off the curb and in the vegetation and tight up against the Town Center Mall sign in the median for the main entrance. As I approached, a white male, later identified by his Florida driver license as Ryan Gargiulo who had been standing next to the driver's side of the vehicle, got into the vehicle upon seeing me pull up. Gargiulo then backed the vehicle up and off the curb and appeared to be attempting to leave; however, I activated my overhead lights and siren. Gargiulo stopped and I approached while he was still seated in the driver's seat of vehicle and behind the wheel of the Lexus.</p>									
	<p>I asked Gargiulo what happened. According to Gargiulo, he was heading westbound on W Glades Road and making a left turn at approximately 35 mph into the main entrance to the mall when he lost control of his vehicle to which he attributed to the roads being wet, which they were slightly but not horribly. Gargiulo stated that he just wanted to go home and leave. I told him what about making a crash report for the property damage he had caused and he replied that he wasn't trying to leave; however, he did want to go home. It should be noted according to the tire marks on the roadway, it appears Gargiulo over corrected his left turn and turned too hard to the left causing the back end of the Lexus to swing out and him to lose control of the vehicle striking the curb and sign in the median.</p>									
	<p>While speaking with Gargiulo, I could smell an odor of an alcoholic beverage emanating from his breath as he spoke. His eyes were also glassy and bloodshot. I informed Gargiulo that my crash investigation was now complete and I was beginning a criminal DUI investigation. I advised Gargiulo of his constitutional rights for which he stated that he understood them and was willing to speak with me. According to Gargiulo, he was coming from his house, where he denied having any alcoholic beverages tonight and then</p>

<p>getting into the crash in front of the mall. He reaffirmed that he was the one driving the Lexus and got into the crash and no one else was in the vehicle with him. He also stated that the vehicle is his and while family and a few friends may use his car from time to time, no one else has used his vehicle in several days. I then asked if he would participate in roadside exercises. He replied yes. The exercises were performed on a flat and level surface, free of debris. He advised that he did not have any physical injuries or disabilities that would prohibit him from completing the exercises.</p> <p>HGN: There was lack of smooth pursuit seen in both eyes. There was distinct and sustained nystagmus seen in both eyes at maximum deviation. Onset of nystagmus was also seen prior to 45 degrees. Vertical nystagmus was not seen. He also had a slight sway and had to be told not to move his head.</p> <p>Walk and turn: He was unable to maintain the instruction stance because failed to listen to instructions and stepped out of position. He also started several times before being told to do so.</p> <p>One Leg Stand: He used his arms forward for balance and his foot was not parallel to the ground as instructed.</p> <p>Finger to Nose: R,L, R,L,L,R. His first right finger he touched the tip of his nose and held his finger there until I had to remind him to return it to his side. His first left finger he touched the tip again; however, he forgot again to return it to his side even though we had just talked about it again. He then suddenly remembered and brought his finger back to his side. His second right finger he touched the tip. However, on his second and third left finger he touched the right side of his nose. Third right finger he touched the tip. He also swayed slightly and eyelid tremors were seen. Based upon the eyelid tremors and bloodshot eyes, I asked about marijuana use and he denied using marijuana ever.</p> <p>Numbers: He was instructed to count from 25 to 75. He had a slight sway. He also did not keep his head all the way back; the higher he counted the further his head came forward, almost to an upright position.</p> <p>Based upon my investigation, I have probable cause to believe that Ryan Gargiulo unlawfully did drive or be in actual physical control of a vehicle while under the influence of alcoholic beverages, or chemical substances as set forth in F.S. 877.111, or any substance controlled under Chapter 893 or any combination thereof, to the extent that his normal faculties were impaired, or while having a blood or breath alcohol level of .08 or higher, and during the course of driving a vehicle while under the influence of alcoholic beverages, or chemical substances as set forth in F.S. 877.111, or any substance controlled under Chapter 893 or any combination thereof, did cause or contribute to the cause of damage to the property of Town Center Mall, contrary to</p>

Florida Statute 316.193(3) (a), (b) and (c) (1). At approximately 0319 hours, I placed Ryan Gargiulo under arrest for DUI.

Search incident to arrest, Officer Alzamendi found a green leafy substance inside a clear plastic baggy inside the center console armrest of Gargiulo's vehicle. Using a Duquenois Levine marijuana test kit, the green leafy substance which weighed 3 grams with the plastic baggy, tested positive for marijuana. Gargiulo denied that the marijuana belonged to him; however, he stated no one has used his vehicle in several days and it is registered him. According to Officer Alzamendi there also was a small amount of loose marijuana that was strewn about the front passenger seat of the vehicle. Gargiulo was additional charged with the possession of the marijuana. The baggy of marijuana was dropped into evidence.

I transported Gargiulo to the Boca Raton Police Department for breath alcohol testing. Officer Bissoon and I performed the twenty minute observation and Officer Bissoon conducted the breath testing process. I asked Gargiulo if he would provide a sample of his breath for breath alcohol testing and he said "no". I read implied consent for which he stated that he understood. I then asked again for breath and he again said "no" at 0403 hours; a refusal affidavit was completed. I again advised him of his constitutional rights; however, this time he refused to answer my questions. Gargiulo was then transferred to the Palm Beach County Jail.

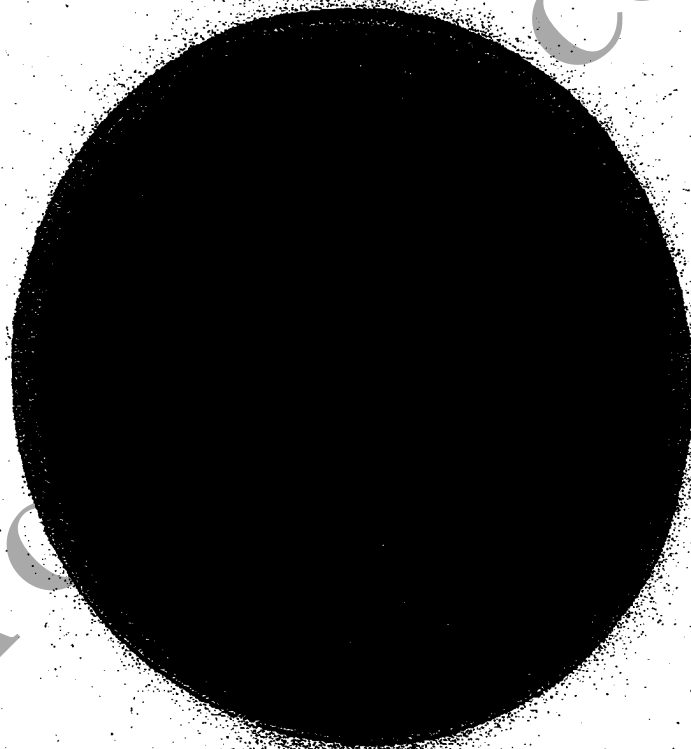

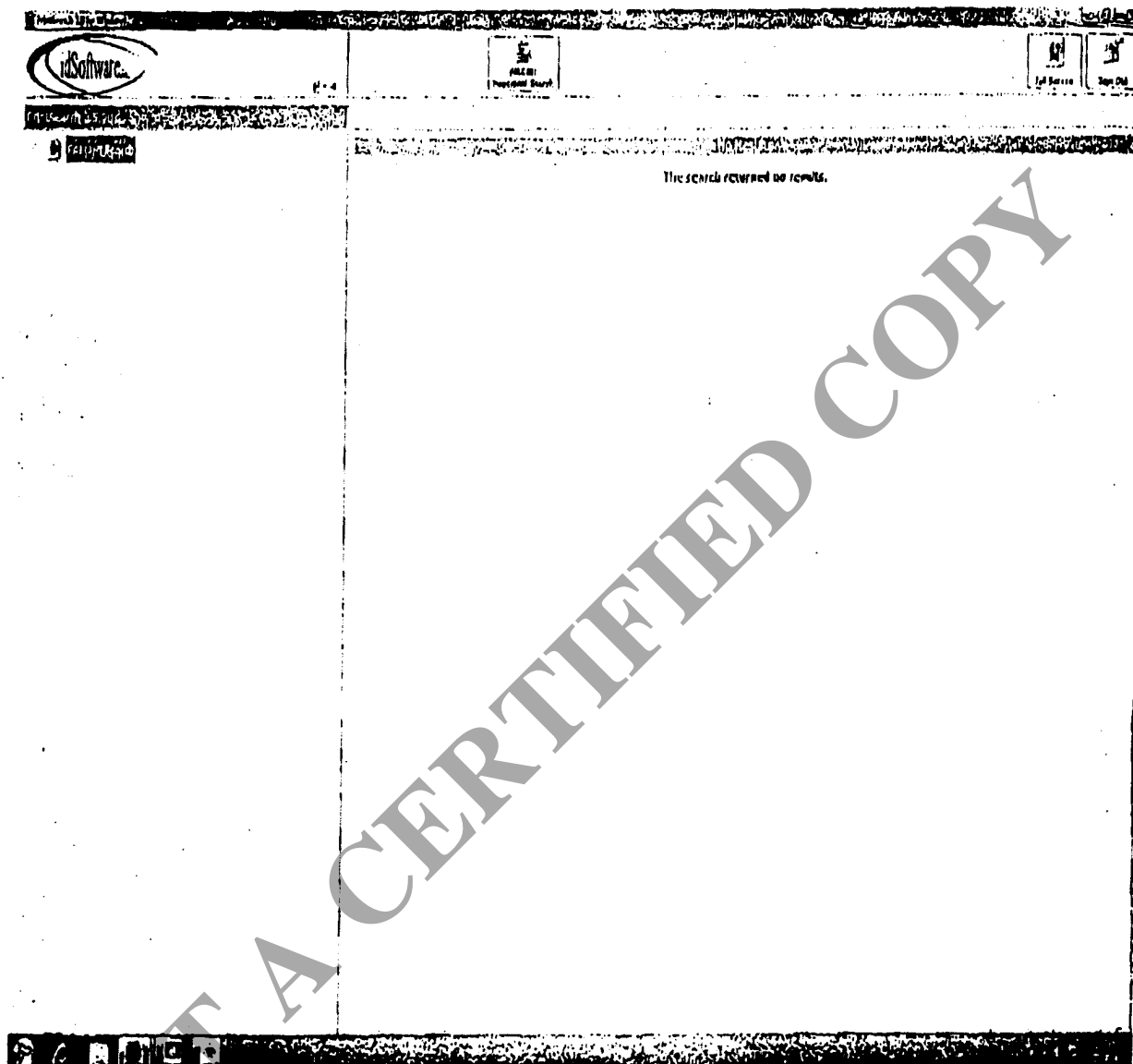
