On Monday, March 12, 2018, at approximately 0042 hrs Myself and FTO Rodriguez ID# 13919 were heading Westbound on Woolbright Rd, Unincorporated Boynton Beach FL when we observed a Black BMW bearing FL tag# EQZV25 stop for a red light and stopped the vehicle on a crosswalk. We then ran the tag through Palm Beach County dispatch, dispatch advised the tag does not exist. When the light turned green, the BMW headed Southbound on Military Tr. We then activate are emergency lights and conducted a traffic stop on the BMW in front of 11211 Military Tr.

Prior to approaching the vehicle, I observed a second passenger in the front passenger seat of the vehicle. Due to tint on the windows I had the driver exit the vehicle and come back to the front of my patrol vehicle. I then identified the driver by his Florida drivers license as Ryan David Ritter WM 3/5/94. I advised Ritter that he was being stopped for stopping on a crosswalk and for having a tag attached that was not assigned. Ritter advised he had just transfered the vehicle from his father and was unsure why it came back not assigned. I asked Ritter if he had anything in the vehicle in which I should be concerned, like drugs or weapons. Ritter advised he did not at which point I asked he minded if i conducted a search of the vehicle. Ritter nodded his head and verbally advised I could search the vehicle. Prior to searching the vehicle I had the passenger step out of the vehicle and confirmed his identity as Curtis Warren Carson WM 4/18/95 verbally and through his Florida drivers license.

Upon entering the front drivers side of the vehicle I immediately smelled a strong odor of what is known to me as Marijuana based on my training and experience. I checked the inside compartment of the vehicle and did not locate anything. I then open the trunk of the vehicle and immediately smelled a stronger odor of marijuana emanating from the trunk of the vehicle. While searching the trunk of the vehicle I observed a pair of light brown Wolverine work boots. When I turned the boots over a clear baggy containing a green leafy substance fell out of the boots. The substance was field tested and yielded a positive result for marijuana. Also while searching the vehicle in the front passenger side, a brown bottle with a white and blue cap containing a red liquid substance was found in a McDonalds bag on the passenger side floor where Curtis was sitting.
