PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:

On the above date and time, I responded to the parking of 501 SE 18th Ave (Publix) in reference to a Suspicious Vehicle. Let it be noted that this incident occurred within the City of Boynton Beach, Palm Beach County, Florida. Anonymous caller advised that there was Silver VW Passat bearing Florida tag CSLK63 in the handicap parking spot in front of the business. Caller advised that the driver keeps revving the engine then exiting and walking around the vehicle. Caller advised that the vehicle had front end damage and the driver kept inspecting it. Boynton Beach Communication advised that the vehicle's license plate was expired and that there was a seize tag order on the vehicle if the registered owner was operating the vehicle.

As units, to include myself, arrived on scene Officer Sohn located a vehicle matching the above description in the north part of the parking lot, facing north in the westbound/eastbound lanes. As Officer Sohn pulled up behind the vehicle he verified that it was the vehicle question. Officer Sohn advised that the vehicle was stopped in the middle of the travel lanes, blocking it. As Officer Sohn exited his vehicle the driver, later identified of W/M Schmedeman, Ryan (03/06/76), turned off the motor to the vehicle and exited the front driver's door. At that moment I approached Officer Sohn and Schmedeman location. While overhearing Officer Sohn's and Schmedeman's conversation I noticed that Schmedeman's speech with thick and slurred. Schmedeman would sway side to side as he spoke. I also noticed that his eyes were bloodshot/glassy. I overheard Officer Sohn ask Schmedeman if he had consumed any type of alcoholic beverages tonight which Schmedeman first stated no, then stated yes; one beer. Schmedeman's vehicle did have body damage to the front right corner and to the center of the rear bumper. See Officer Sohn's supplement for further.

Minutes later I began to speak with Schmedeman. Schmedeman advised that he was going through a break up and things haven't been working out for him lately. Schmedeman advised that he went to Publix to get some food and then was heading home. Schmedeman advised when he observed red and blue lights behind him he stopped his vehicle. Let it be noted that at no point did Officer Sohn activate his emergency equipment to initiate a traffic stop on Schmedeman. When Officer Sohn pulled up behind Schmedeman as he was stopped in the middle of the parking lot Officer Sohn activated his "cruise lights" which are a solid red and blue light. While speaking with Schmedeman I could detect the odor of

an unknown alcoholic beverage emitting from his breath, which intensified as he spoke. I asked Schmedeman his had consumed any type of alcoholic beverages tonight which he stated yes. Schmedeman advised that he wanted to be honest with me and stated that he had five Miller Light beers at his residence, prior to driving to Publix. Schmedeman continued to sway side to side as he spoke with me.

At this point I requested Schmedeman he would submit to a Series of Standardized Field Sobriety task, which he agreed to. Prior to beginning I asked Schmedeman if he had any injuries and/or disabilities I should be aware of, which he stated no. Schmedeman advised that he does not take any medications as well. See the following:

Pen Exercise: During the task Schmedeman swayed side to side and had a difficult time following the stimulant with his eyes only and not moving his head.

WALK AND TURN:

The following task was demonstrated and explained to Schmedeman, which he stated that he understood. During the instructional stage, Schmedeman had a difficult time keeping his balance. Schmedeman started the task to soon. During the walking stage, Schmedeman missed heel to toe between his 5-6 and 7-8 step. Schmedeman completed an improper turn. On the returning steps, Schmedeman missed heel to toe between his 5-6 step and stepped off the line to the left on step number 5.

ONE LEG STAND:

The following task was demonstrated and explained to Schmedeman, which he stated that he understood. During the instructional stage, Schmedeman swayed side to side. During the balancing stage, Schmedeman raised his right leg, dropping it 3 times prior to the 30 seconds. Schmedeman used his arms for balance through-out the exercise and lost his balance. Schmedeman advised if his could switch legs as the exercise was competed.

FINGER TO NOSE:

The following task was demonstrated and explained to Schmedeman, which he stated that he understood. During the instructional stage, Schmedeman swayed side to side. During the exercise stage, Schmedeman missed the tip of his nose on his first Left command. The remainder of the exercise, Schmedeman utilized the middle of his index finger instead of the tip to touch the tip of his nose. Schmedeman had his eyes half opened during the task. Schmedeman swayed during the task.

ROMBERG/ALPHABET:

The following task was demonstrated and explained to Schmedeman, which he stated that he understood. During the instructional stage Schmedeman swayed side to side. During the exercise stage had his eyes half opened and recited the alphabet correctly.

Based on the above facts, Schmedeman was placed into custody under suspicion of DUI (D/L and Spaced). Schmedeman was then placed in the back seat of vehicle #4519 (Officer Kromrey) and was transported to the Palm Beach County BAT facility I started my 20 minutes observations at 2208hrs and completed it at 2218hrs. Upon completion I requested Schmedeman to provide a sample of his breath to determine the alcohol content, which he refused. I then read Schmedeman Implied Consent, which he stated that he understood. I then requested a second time, which Schmedeman refused again. Miranda Warnings were read to Schmedeman, which he advised that he understood. Schmedeman refused to complete the Q&As.

Driver license check revealed that Schmedeman's license was currently suspended as of 01/22/19. Due to the seized tag order Schmedeman's license plate was removed from his vehicle and later entered into the Boynton Beach Police Evidence Department.

Based on the above facts I've established Probable Cause to arrest Schmedeman with DUI pursuant with F.S.S. 316.193.1. and DWLS pursuant with 322.34.2. Schmedeman was processed and later TOT PBCJ.

Incident was captured via BWC. Schmedeman's vehicle was removed from scene by Beck's Towing. A photo was taken of Schmedeman's location within the parking lot and later entered into evidence.
