

 On the **17** day of **March**, **2018** at **23:11** (Specifically include facts constituting cause for arrest.)

On 03/17/2018 while patrolling I ran the tag to a 2017 Ford bearing F1 tag#HCYX52 and the registration was expired as of 04/18/2017. I then stopped the Ford at 1000 N Federal Hwy and met with the driver Ryan Miller and I advised him the reason for the stop was due to his registration being expired. Miller stated that he was aware and working on it. I then asked him for his driver's license, registration and proof of insurance. He only provided me with his Florida driver's license. While speaking with Miller, I could smell a strong odor of an alcoholic beverage emanating from his person, his eyes were blood shot and glossy. Miller was also slurring his speech. I asked Miller if he had anything to drink tonight and he stated that he had three beers. Ofc Gannon arrived on scene as my backup.

I then asked Miller to exit the vehicle and walked him to the front of my patrol vehicle. Based on my observations I asked Miller if he would submit to roadside sobriety tasks and he stated that he would submit to the tasks. I then walked him over to a well-lit area and asked him if he had any medical problems or medical issues that would prevent him from doing the tasks. Miller advised that he had no medical issues that would prevent him from doing the tasks. The tasks that were conducted were the Walk and Turn, One Leg Stand, Finger to Nose, and the Rhomberg Alphabet.

The first SFST was the Walk and Turn. Miller couldn't maintain the starting position. He made an improper turn by just turning around instead of the way I instructed him. Miller also stepped off the line several times and stumbled as he conducted the task. He failed to keep his feet heel to toe as he walked the line.

The second SFST was the One Leg Stand. Miller failed to keep his foot six inches off the ground. Miller swayed during the task and failed to count as instructed. Miller didn't keep his hands to his sides as instructed but had them out like an airplane.

The third SFST was the Finger to Nose. (L-R-L-R-R-L). Miller started before he was told to begin. On the first left he placed the pad of his finger and kept it on his nose for an extended amount of time. I then asked him if he understood the instructions and Miller advised that he was waiting for me to tell him to bring his finger down. I advised him of the instructions again and continued with the task. On the first right, he touched the side of his nose; second left he touched his left nostril; second right he touched under his nose; on the third right he touched the tip of his nose; on the third left he touched his right nostril. Miller also opened his eyes during the task.


The fourth SFST was the Rhomberg Alphabet. He was unable to recite the alphabet correctly. Based on the above information I placed Miller under arrest for DUI. I then transported him to the BRPD.

Ofc Pare responded to BRPD as the Breath Test Operator. Ofc Pare and I conducted the 20-minute observation and then he was taken into the BAT room. Miller advised he would not provide a breath sample. I then read him, his Implied Consent Warnings, which he advised he understood and he still would not provide a breath sample. I also read Miller his Constitutional Warnings which he advised he understood and he said he wouldn't answer my questions without an attorney present. See DUI influence report.

Miller is being charged under F.S.S. 316.193(1) for DUI. Miller is also being issued a citation for the expired registration under 320.07(3b) and being charged for DWLS without knowledge under F.S.S 322.34(1). Miller was turned over to Palm Beach County Jail for further processing. Miller's vehicle was towed by Emerald towing.
