**Narrative:**

In the City of Boynton Beach, within Palm Beach County, I was dispatched to a 25 Country Lake Cir. in reference to a domestic.

Upon arrival, I met with white male Ryan Schneider who told me that he had been a verbal dispute with his wife, white female Sylvia Mervis, that turned physical. Schneider told me that he was holding his son, white male juvenile Jack Schneider (DOB 06/26/2015), while he was having an argument with Mervis over silverware. Mervis went to grab Jack from Schneider's arms during the verbal dispute, at which time Schneider pushed her away with his right foot. At that time Schneider and Mervis were struggling over possession of Jack as they were simultaneously scratching each others face. I observed a red mark on Mervis's right cheek and a small laceration to Schneider's left cheek. Mervis did confirm Schneider's accounts of the incident and added that she felt she needed to defend herself and her child. Schneider admitted that he had no desire of harming Jack during the incident. Both Mervis and Schneider advised that Jack's head was brushed against their bodies during the struggle causing no physical injury. I checked Jack and did not observe any laceration, bruising, or swelling during Mervis' and Schneider's physical altercation. I attempted to talk to Jack about his recollection of the incident, but was unable due to his education level and speaking capabilities. Jack did appear in good health physically, mentally, and emotionally.

A check on FCIC/NCIC produced negative results on any wants/warrants.

Based on the above stated facts, Schneider (primary aggressor) was placed under arrest for domestic battery in violation of FSS 784.03.1a1. Schneider was processed at BBPD and then taken over to PBCJ.


