**NARRATIVE:**

On 09/25/2017 at 2307 hours, I responded to 107 South J St, within the city of Lake Worth, Palm Beach County, Fl, in reference to a male possibly on drugs acting erratically in the area.

Upon arrival, I met with PBCFR #91 Run #17104198 in the 100 block of South J St, where they had already come in contact with a white male, later identified verbally as Ryan Therrien. Fire Rescue explained upon making contact with Ryan, Ryan became combative, climbed onto a roof which he then jumped off of, and cursed at them.


I then made contact with Ryan. Ryan was sweating profusely, his pupils were dilated, and he was breathing heavily. Ryan spoke to me in a calm and collected manner. I asked Ryan if he wanted to harm himself and if he would like to voluntarily meet with a health care professional, which he declined. When I asked Ryan why he had jumped from the roof and was trying to evade PBCFR, he told me he had no recollection of any of his actions. Based on his statements and actions, I found Ryan to be a danger to himself and others, and that he met the criteria for an involuntary Baker Act. When I informed Ryan I would be taking him to the hospital, he stated "I'm going to fight you" and turned to face me.

Upon hearing Ryan's statement and seeing his change in posture, D/S Goodman ID# 26786 took a position of cover on Ryan's right side. When Ryan saw D/S Goodman reposition himself, he turned towards D/S Goodman, Clenched his fists, and began to lunge forward towards D/S Goodman. Fearing an attack on D/S Goodman, I attempted

to apprehend Ryan by grabbing his left arm at the tricep and wrist and attempted to perform and armbar takedown. Utilizing the momentum from the armbar takedown, Ryan then turned his body towards me and aggressively swung his right fist towards my head. I was able to duck under his swing, however I believe if I had not moved, Ryan would have punched me directly in the side of the head. Due to my evasive maneuver, Ryan was able to break free of my grip and began running south bound on South J Street. D/S Goodman and I gave chase and I was able to grab Ryan again by the right arm at the tricep and wrist. Utilizing his forward momentum, I guided Ryan down towards the ground, where he landed flat on his stomach. After compliance was gained, Ryan was secured in handcuffs which were double locked, and later checked for proper fit and tightness.

Based on my investigation and Ryan's actions, I found Ryan to be in violation of F.S.S 843.01 and 784.07(2)(a). Ryan was also Baker Acted under PBSO Case #17131799.
