The following occurred in the unincorporated West Palm Beach area, Palm Beach County, Florida:

On the above date and time, I was actively engaged on a traffic stop in the area of Woodstock Drive and North Military Trail when I heard a loud "crash" consistent with a car accident behind me. I turned around and saw a black Nissan Altima had just struck a Black Mazda 6 sedan that was attempting to make a U-turn North on Military Trail. I observed the driver and sole occupant of the black Mazda 6, later identified as Sebastian Galeano (W/M DOB 12/15/87), still sitting in the driver's seat of the vehicle when I approached it. Galeano exited the vehicle and advised "my brakes didn't work". While speaking with Galeano I could detect the strong odor of an alcoholic beverage coming from his person. Galeano had slurred speech and red glossy eyes consistent with alcohol consumption. Due to the indicators of impairment, a DUI unit was called to the scene to conduct a DUI investigation.

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 7/7/18 I responded to Military Trail/ Woodstock Dr., in Palm Beach County, in reference to a traffic crash with a possibly impaired driver. Upon arrival I met with Cpl. Webster id 25486, who had witnessed the crash.

Cpl. Webster advised that while he was conducting a traffic stop he heard a loud crash. He then turned around and saw that a black Nissan had struck a black Mazda. The Mazda was traveling southbound and attempting to make a U-turn, turning in front of the Nissan. Cpl. Webster made contact with the driver of the Mazda, later identified as Sebastian Galeano, the sole occupant of the vehicle. Cpl. Webster noticed that Galeano had red glossy eyes, slurred speech, and the odor of alcohol coming from his breath.

Cpl. Webster positively identified Galeano as the driver and provided a sworn statement.

## OBSERVATION OF DRIVER:

I met with Galeano, who was sitting in his vehicle with the door open and his. I had Galeano walk to the front of my patrol car. I noticed that Galeano was unsteady while getting out of the vehicle and used the vehicle for support. While walking Galeano almost tripped over the median and had to pause to steady himself. Galeano's eyes were red and glassy and he swayed while standing still. There was an odor of an unknown alcoholic beverage coming from Galeano breath, which got stronger when he spoke.

I advised Galeano that the traffic crash investigation was complete and I was going to conduct a criminal DUI investigation, which he advised he understood. I read Miranda warnings to Galeano, which he advised he understood. Galeano advised that he was not injured from the crash and did not need EMS. Galeano advised that he did not hit his head or lose consciousness during the crash. Galeano advised that he was not taking any medications or illegal drugs. Galeano admitted to having 2 drinks prior to driving. Based on my observations and Galeano's admission to drinking I asked Galeano to perform standard field sobriety tasks.

## DRIVER'S STATEMENTS:

Had 2 drinks prior to driving. While performing roadside tasks Galeano advised he was unable to perform the tasks.

## ODORS:

STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM SUBJECT'S BREATH.



**Other Observations:**

Galeano was asked to stand with his feet together and place his hands by his sides. Galeano was asked to focus on the stimulus and follow it with his eyes. Galeano was told not to move his head to assist in following the stimulus. Galeano showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. I saw distinct and sustained Nystagmus at maximum deviation and onset of Nystagmus prior to 45 degrees in both eyes. Galeano swayed while performing this task and had to be reminded to follow the stimulus and not to move his head.

**WALK & TURN:**

Galeano was placed in the instructional stance for the walk and turn task. The task was explained and demonstrated to Galeano. During the instructions Galeano failed to maintain the instructional stance and attempted to begin the task prior to being instructed to do so. Galeano acknowledged the instructions prior to performing the task.

During the task Galeano stepped off the line and missed heel-to-toe steps several times. Galeano used his arms for balance and paused several times to steady himself. Galeano did not turn as instructed and took the incorrect number of steps.

**ONE LEG STAND:**

Galeano was placed in the instructional stance for the one leg stand task. The task was explained and demonstrated to Galeano. During the instructions Galeano attempted to begin the task prior to being instructed to do so. Galeano acknowledged the instructions prior to performing the task.

During the task Galeano swayed and used his arms for balance. Galeano put his foot down multiple times prior to 30 seconds elapsing.

**FINGER TO NOSE:**

Galeano was placed in the instructional stance for the finger to nose task. The task was explained and demonstrated to Galeano. Galeano acknowledged the instructions prior to performing the task.

During the task Galeano missed touching the tip of his nose several times. Galeano started to use the wrong hand and did not keep his head tilted back.

**ROMBERG ALPHABET:**

Galeano was placed in the instructional stance for the Romberg alphabet task. The task was explained and demonstrated to Galeano. Galeano acknowledged the instructions prior to performing the task.

During the task Galeano swayed. Galeano incorrectly recited the alphabet making multiple errors. Galeano attempted to recite the alphabet in spanish and also made multiple errors.


