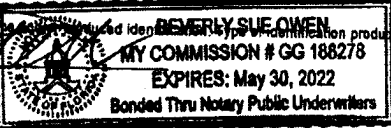

As I approached I observed a white female sitting in the driver's seat with the keys in the ignition and the engine running. The female appeared to be asleep, at which time I turned/removed the keys from the ignition and turned off the engine. The female later identified via FL DL as Sadie Humes, awakened at which time I informed her why I was making contact with her. I then asked Humes to step out of the vehicle. Once outside the vehicle I detected an odor of alcoholic beverage emerging from Humes breathe. Humes stated she was only asleep because she had been drinking and was tired. Humes had slurred speech and was very unsteady on her feet. DUI Unit 10 Deputy White then responded and took over the investigation.

On Friday, May 10, 2019 at approximately 2343 hours, I responded to the intersection of Palmetto Park Drive and State Road 7, in the Chillis parking lot, located at 21769 State Road 7, Boca Raton (Palm Beach County) Florida in reference to a possible impaired driver who was in actual physical control of her vehicle. While en route to this location I was informed that Palm Beach Fire Rescue responded to assess the driver for medical issues. She refused treatment, however. Upon my arrival I noticed Palm Beach County patrol vehicles stopped in the parking lot around a gray vehicle. I also noticed a white female standing toward the back of the gray vehicle. I made contact with Deputy J Engers who told me he was dispatched to the previously mentioned location in reference to a female asleep inside the driver seat of her vehicle. When he arrived he saw a gray Chevrolet Cruz on the north side of the parking lot with the engine running. She appeared to be asleep and he reached inside the vehicle to remove the keys from them ignition. D/S Engers could smell an odor of an unknown alcoholic beverage coming from her breath and suspected her to have been drinking. D/S Engers wrote a sworn witness statement on a probable cause affidavit regarding his involvement with this case.

I made contact with the driver who was still standing at the rear of her vehicle. She was later identified as Sadie Rose Humes by their Florida driver license. Humes was upset and argumentative. I attempted to explain the reason why she was encountered by the police. She was overbearing and not allowing me to speak without being interrupted. During my encounter I noticed her eyes were red, watery and glossy. Her cheeks were flushed and her mouth was dry. She slurred her speech while speaking and she was unsteady while standing. I could smell a strong odor of an unknown alcoholic beverage emanating from her breath that intensified when she spoke. I explained to her that she was in actual physical control of her vehicle while sitting in the driver seat with the engine running. She continued to exclaim that she was not driving her vehicle. Moreover, she uttered that she was too drunk to drive and sitting inside it was a smart thing to do. She also said she did not endanger the life of others by sitting in her vehicle. I told her I had a suspicion that sh) had been drinking an unspecified amount of alcoholic beverages. Additionally I asked if she would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if she was impaired while she was sitting in the driver seat of her vehicle. She refused to perform the tasks and asked for her lawyer. I explained Taylor Warnings that informed her performing the SFSTs were voluntary and she did not have to comply. However if she did not comply I would only be left with the evidence before me {previously mentioned indicators} which could be strong basis of her being placed under arrest for DUI. As I explained the warnings she resumed being overbearing and refused to listen. Eventually I was able to complete the warnings. Afterward I asked if she understood the warnings. She told me she was not doing the tasks and wanted her lawyer. Since Humes was not willing to perform the SFSTs and based on the complaint received of the defendant being asleep in the driver seat of her vehicle with the engine on, that was observed by D/S Engers, coupled with my observation of personal indicators of impairment exhibited by the defendant, probable cause was established for DUI. I told the defendant she was being placed under lawful arrest for DUI. She was searched and handcuffed (double locked and checked for tightness) prior to being seated into the rear of my patrol car. During an inventory search of her vehicle we located a bottle of Absolute Vodka and Cambridge whiskey inside her black pocket book. Both bottles had liquid contents inside them. On scene deputies arranged for a rotation tow to respond to impound the defendant's vehicle. Emerald Towing company responded and towed the vehicle to their lot. Meanwhile I began transport to the main jail breath analysis facility for further processing. Upon our arrival I escorted her into the facility and began a 20 minute observation period. During this time she ingested nothing into her body orally or otherwise. She also did not regurgitate. After the observation period was satisfied, I escorted her into the testing room and asked her to give breath samples. She refused. I read her implied consent and asked if she understood it. She said she did but refused to give breath samples. At this time she was deemed a "refusal". Since she asked for a lawyer I decided to forgo Q&A. The defendant was cited for have an open container of an alcoholic beverage. She was booked into the main jail for DUI.

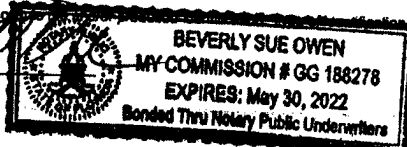
