P	<p>On 10/25/2016 at approximately 2118 hours, I was conducting a foot patrol at 311 W Indiantown Rd., in the Town of Jupiter, Palm Beach County, FL. The aforementioned business has a trespass authorization letter on file, requesting Jupiter Police Officers to enforce trespass violations on the manager's behalf. At the time, I was wearing an authorized Jupiter Police Department uniform, clearly identifying myself as a Police Officer.</p>								
R	<p>On the west side of the building, near the air conditioning unit, I located a white male, later identified as Saleem Usman (DOB 12/15/1963), lying on his side. Usman was lying in between bushes on the west side of the building, between the exterior of the building.</p>								
O	<p>As I approached Usman, it appeared as if he was sleeping because he was not responding to me when I called out to him. After several attempts to wake Usman up, Usman opened his eye, sat up, and began talking to me. I asked Usman if he had been contacted by the police before about trespassing on the aforementioned property and he stated that he spoke to police a few weeks ago on the other side of the building. As Usman stated this, he pointed to the northeast corner of the building. Usman further advised he was sleeping at this location and trying to stay "out of sight."</p>								
B	<p>I proceeded to run Usman through dispatch, who advised there was an indefinite trespass warning issued to him on 05/18/2016 (reference JPD Event # 16-128299).</p>								
E	<p>I subsequently asked Usman to stand up and placed him under arrest. I placed handcuffs on Usman's wrists which were checked for proper spacing and double-locked to prevent tightening. Usman stated he had screws in his lower back and was unable to put his arms behind his back so I handcuffed Usman in the front. Usman was transported to the Jupiter Police Department temporary detention facility (Cell # 1) until arrest paperwork was</p>


