Upon my arrival I made contact with the complainant/victim later identified as Sean Furiong . Sean advised that his Wife/suspect Samantha Furiong were involved in a verbal argument. Sean further explained that Samantha during the argument then became violent and pushed him not allowing him to leave the residence. Sean then stated that Samantha approached him and struck him in the face with an open hand. Sean then immediately dialed 911 and notified the dispatcher over the phone that Samantha struck him in the face. I observed a laceration which was bleeding on the top left of Sean's head which was consistent with the allegations he stated.

Soon there after, I made contact with Samantha whom advised that she was involved in a verbal argument with her Husband Sean. Samantha further explained that Sean was attempting to leave the residence to head to a bar. Samantha didn't want Sean to take her vehicle due to having to take the kids to school in the morning and having to utilize the car to go to work. Samantha stated that at no time was the argument physical in nature.

Based on the following fact and statements, i find probable cause to charge Samantha Furlong with Florida State Statute 784.03(1) as she did actually and intentionally touch or strike Sean against the will of Sean {or} did intentionally cause bodily harm to Sean and Sean was a family or household member of Samantha.

I placed Samantha under arrest and placed her in D/S Blastre patrol vehicle. D/S Blastre then proceeded to take her to Palm Beach County West Detention Center for processing and booking without incident.
