 On the 28 day of December, 2017 at 22:54 (Specifically include facts constituting cause for arrest.)

On December 28, 2017 at 2240 hours, I conducted a traffic stop in the 3000 Block of South Ocean Blvd, on a Ford F-150 bearing the Florida tag number J863PV for a non-working tag light.

I made contact with the driver Steven Amaral (W/M DOB 10/14/1958), and I advised him of the equipment issue with his vehicle. The passenger Samantha Fortney (W/F DOB 05/29/1991) seemed nervous, and was trying to cover her arms by pulling down her long sleeve tee-shirt. I noticed, based on my training, and experience multiple track marks on both of her arms consistent with heroin use. I asked the driver/registered owner of the vehicle for consent to search the vehicle, and he advised that it was okay to be searched. I asked the passenger if I could search her purse, and she stated "okay there isn't anything in there."

Upon lawful search, I located in the right side pocket of the purse a "push pipe" which with my training and experience is used for Crack Cocaine. Fortney upon noticing what I discovered asked me not to continue looking in her purse at which time, I advised her that based on the paraphernalia I had the probable cause to continue my search.

I located a red glasses case inside the purse that contained two syringes, one loaded with heroin, a clear capsule that contained heroin in powdered form, a crack pipe containing crack cocaine, and the push pipe. The crack cocaine tested positive using the Narco Test 4 for Cocaine HCI & Free-Base Reagent, and the Heroin tested positive using the Narco Test Kit 16 for Heroin.

Based on the listed facts above Fortney was arrested at 2254 Hours, and charged with Possession of Cocaine pursuant to F.S.S. 893.13(6A), Possession of Heroin pursuant to F.S.S. 893.13(6A) x2, and Possession of Paraphernalia pursuant to F.S.S. 893.147.
