PROBABLE CAUSE AFFIDAVIT	<p>Florida State Statute 810.11 reads "(1)All persons are prohibited from placing, posting or erecting signs upon land or upon trees upon land adjacent to or adjoining all public highways of the state, without written consent of the owner of such land, or the written consent of the attorney or agent of such owner. (2) Every person convicted of this section shall be guilty of a misdemeanor of the second degree ..." Today, above date and time I observed defendant standing in the grass area next to the road way, specifically 10th Ave No. In his hand he was holding a small "snipe" sign which read "FOR RENT", and the sign had a phone number listed on it. I made contact with the gentleman and I immediately recognized him as I have spoken to him about this type of activity in the past. Approximately one year ago I was working with code enforcement reference the problem of large amounts of illegal snipe signs being placed all over the county. I made contact with Mr. Zeqiraj at his office after he was identified as one of the most prolific suppliers of illegal signs in the county. I specifically advised him about FSS and the fact what he was doing was illegal. I identified the specific statutes, as well as Palm Beach County ordinances which prohibit him from placing illegal signs along the right of way. At the time, he stated he understood the law and would comply. Today when I observed him once again placing an illegal sign along the road way, I asked had he recalled our conversation, and he stated he had, but felt the law did not apply to him because other individuals also place illegal signs along the road way. I advised him he was in violation of FSS 810.11, and he was taken in to custody. It is noted he had parked his vehicle on the property of a gas station which was located at 2201 10th Ave No. Upon parking on the property, he walked across their parking lot in order to access the right of way along 10th Ave No. The gas station has official PBSO Posted No Trespassing signs located on the property and they owner has a No Trespassing affidavit on file with PBSO. Because Mr. Zeqiraj was on the gas station property without a legal or valid reason, he is in violation of FSS 810.09.2b, trespassing after posted warning.</p>
