On the **9th** day of **February** 20 **18** at **1943** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On Friday, February 09, 2018 at approximately 1943 hours I responded to 6208 Santa Catalina, in unincorporated West Palm Beach, Palm Beach County Florida 33415 in reference to a domestic battery investigation.

Upon my arrival I made contact with the complainant/ victim who was later verbally identified as Maria Benitez Villatoro (DOB: 01/02/1993) who advised the following:

Ms. Benitez Villatoro only speaks Spanish due to a language barrier her roommate who was on scene was able to translate. Ms. Benitez Villatoro advised her boyfriend and father of her child who was later verbally identified as Samir A. Figueroa (DOB: 03/28/1993) was arguing with her over money issues. She advised Mr. Figueroa had been sitting outside of the residence consuming alcohol. Ms. Benitez stated she told Mr. Figueroa to stop drinking and to stop wasting his money on alcoholic beverages. She stated Mr. Figueroa began yelling at her and told her to mind her own business. She said Mr. Figueroa then struck her in the right side of her face with a closed fist. She stated she fell to the ground at which time Mr. Figueroa left the scene in an unknown direction of travel. While on scene I observed Ms. Benitez Villatoro had bruising and swelling to the right side of her face and behind her right ear. Ms. Benitez Villatoro refused any medical treatment at this time.

While conducting my domestic battery investigation Mr. Figueroa arrive back on scene. I made contact with Mr. Figueroa who advised the following:


Mr. Figueroa stated he returned home from work and he has been arguing with Ms. Benitez Villatoro for several day in reference to money issues. He stated he told Ms. Benitez Villatoro to mind her own business and to not tell him how to spend his money. He advised that he was only yelling at Ms. Benitez Villatoro and did not physically strike her at any time.

Ms. Benitez Villatoro provided me with a sworn written statement of the incident. A Domestic Violence Rights and Remedies Pamphlet and Victim's Rights Information with a PBSO Case Number were provided to Ms. Benitez Villatoro. While on scene I took digital photographs of Ms. Benitez Villatoro, utilizing my PBSO issued Kodak camera. The digital photographs were saved onto a maxflash secure digital (SD) card and then uploaded onto the PBSO Domestic Violence Website. It should be noted while photographing the victim I did observe signs of physical injuries to the right side of Ms. Benitez Villatoro face.

Based on my investigation I have probable cause for arrest of Mr. Figueroa for simple battery on Ms. Benitez Villatoro. FSS. 784.045(1)(a)(1).

At this time I had placed Mr. Figueroa wrist into handcuffs, checking for proper fit and double locked for safety per department policy. I then informed Mr. Figueroa that he was being placed under arrest for domestic battery. I placed Mr. Figueroa to the rear compartment of my vehicle and secured him with a seat belt. I then transported Mr. Figueroa to Criminal Justice Complex at 3228 Gun Club Rd, West Palm Beach FL 33406 where he was turned over to correctional staff without incident.
