On October 15, 2016, I interviewed victim, [REDACTED] who advised that on October 13, 2016, her [REDACTED] Sanford Geraci shot her with an airsoft handgun. [REDACTED] explained that on Thursday, October 13, 2016, she, her [REDACTED] and he [REDACTED] exited their garage and walked onto their front lawn to fix some Halloween decorations. [REDACTED] observed Geraci repeatedly drawing a black airsoft gun from his pants and then firing it to the left and then to the right in the direction of her family. [REDACTED] began filming the incident with her phone.

While [REDACTED] was filming, her three year old son began approaching her. [REDACTED] used her left hand to guide her son back towards his [REDACTED] and as her hand was on his head, she was struck on the knuckle of her finger by a pellet from Geraci's airsoft gun. An inspection of [REDACTED] finger did not reveal any visible marks or injuries. The placement and timing of the shot of the pellet is significant in this investigation. The pellet may have only caused minor injury to [REDACTED] finger, however, if her finger had not been obstructing her three year old son's face at the time than he would have been struck instead of her. Airsoft guns fire their pellets at speeds of hundreds of feet per second, creating a real risk of serious eye injury, which in this case was narrowly missed.

I reviewed the video, which corroborated [REDACTED] statement. [REDACTED] also photographed the white pellet that she was struck with and collected it to turn over to the police. I was provided copies of the video and the white pellet that struck [REDACTED].

[REDACTED] advised during the interview that she was very afraid of Geraci and went on to explain that his behavior has changed since this incident. [REDACTED] described Geraci's behavior as harassment; every time she comes outside with [REDACTED] Geraci paces in his driveway watching them and Geraci started walking his dog on a leash in front of their home, which he had never done previously. [REDACTED] explained that in an effort to avoid Geraci, she no longer enjoys a lot of the time she used to spend outside with [REDACTED]. [REDACTED] advised that her family has been discussing the possibility of moving because of Geraci's irrational and unpredictable behavior.

On October 20, 2016, I informed Geraci's attorney of the allegations made against his client and requested video surveillance from Geraci's residence and an interview with Geraci. Geraci's attorney denied both of my requests.

Following our interview [REDACTED] had called me on two separate occasions informing me that they had an interaction with Geraci, both of which were described to be threatening in nature. On October 23, 2016 at 1924 hours, [REDACTED] explained that her [REDACTED] was in their front lawn when Geraci

approached him with his dog leashed. Geraci asked [REDACTED] if he had time to talk, which [REDACTED] replied that he did not. Geraci went on to state "I hope your kids are good and I just wanted to let you know that tampering with evidence is a serious crime. [REDACTED] walked away from Geraci into his residence but continued to hear Geraci mumble as he did so. Matt described Geraci as appearing "off" during their encounter and explained that Geraci was wearing sunglasses even though it was dark outside.

On Friday, October 28, 2016 at 0846 hours, I received a second phone call from [REDACTED]. She sounded frantic and expressed that [REDACTED] just had another encounter with Geraci and they were frightened. I then spoke with [REDACTED] who explained that he was leaving for work and Geraci began yelling at him from the sidewalk. Geraci started by stating that he believed in the 'Black Lives Matter' movement now. Geraci then explained how important family is and told [REDACTED] "your family is more important than this." Then Geraci asked, "Are you guys the ones claiming that I shot you?" [REDACTED] replied "yes, you hit my [REDACTED]" Geraci asked, "what color BB was it?" [REDACTED] replied "white." And then [REDACTED] described Geraci as laughing out loud towards the sky in an exaggerated manner and stated "I don't even have any white BBs." [REDACTED] did not respond and then Geraci began yelling "don't do it, don't fucking do it." Geraci continued to yell but [REDACTED] got into his vehicle and left for work and reported the incident to me immediately following.

The [REDACTED] also reported the following incidents involving Geraci to Palm Beach County road patrol deputies:

- Wednesday, November 2, 2016: [REDACTED] and [REDACTED] went on a walk through the neighborhood. The [REDACTED] walked north on Cape Delabra, turned west on Serena Creek Avenue that is a closed loop with no exits and returned home. As they were still in view of Geraci, beginning their walk, Geraci got into his vehicle and followed the [REDACTED] around the Serena Creek Ave loop and returned home. Due to there being no exits on this loop or purpose for Geraci to be driving this route, the [REDACTED] were in fear because he was following them.
- Friday, November 4, 2016: [REDACTED] exited their garage and Geraci immediately began yelling in their direction. Geraci yelled things such as "Tampering with evidence is a crime you mother fucker! I'll kick your ass" and instructed his German Shepard to attack from their fenced in back yard." As [REDACTED] and their [REDACTED] were walking passed Geraci's residence to go to a neighbors for a play date, Geraci spit over his fence in their direction.
- Saturday, November 5, 2016: [REDACTED] was washing his vehicle, with the rest of his family also

outside in the garage area. Immediately following [REDACTED] and the kids entering their residence, Geraci exited his front door and yelled to [REDACTED] "Hey, why don't you send your friends (police) over so I can tell them to go home. I'll kick your ass mother fucker." [REDACTED] advised that he did not acknowledge Geraci and pulled the vehicle into the garage and went inside to call the police.

[REDACTED] explained that their family has made several changes to their lifestyle out of fear of Geraci. For example, they explained that [REDACTED] has always been able to pull her vehicle into the garage and close it before exiting, which makes her feel safe from possible interaction with Geraci. However, [REDACTED] has to park his vehicle in the driveway and walk into the residence. Now, [REDACTED] calls [REDACTED] as he is arriving home so that she can open the garage and be nearby as [REDACTED] exits his vehicle and enters the residence just in case Geraci attempts anything again. The [REDACTED] used to spend a lot of time outdoors in their neighborhood with their children but now they are often too afraid to exit their residence and feel as if they are prisoners in their own home. The [REDACTED] explained that Geraci installed surveillance videos on the exterior of their home approximately one year ago but none of those cameras ever pointed towards the [REDACTED] residence. [REDACTED] recently noticed that a surveillance camera on Geraci's residence that once pointed towards the rear of the Geraci property is now turned to point at the [REDACTED] residence. The [REDACTED] stated that it appeared that every time they came outside Geraci would somehow know and also exit his residence to confront them. Therefore, they believe that Geraci is monitoring the front of their residence and takes the opportunity whenever he observes them exit their residence to harass them.

Based on the above investigation, I find probable cause exists that Sanford Geraci violated F.S.S. 914.22(1), Tampering with a Witness, F.S.S. 784.04(1)(a), Stalking (harassment) and F.S.S. 784.03(1), Simple Battery.
