<p>On Jan. 27, 2017, I responded to the parking garage of Midtown Development located at 4731 PGA Blvd. Palm Beach Gardens, FL. 33410 reference to a suspicious person backed into a parking spot in the garage.</p> <p>Upon my arrival, I met with Jupiter P/O Janine Ercolano and FHP Trooper Brigit Handzik who reside in the area. Ercolano and Handzik are the developments courtesy officers and advised that the Red Honda Accord FL. tag EFJH50 was backed into the lower level of the garage and that there was a strong smell of marijuana coming from the vehicle. Both Officers approached the vehicle and noticed someone sleeping in the back seat of the vehicle. They then advised that they noticed a glass pipe in plain view on the drivers side door. From their training and experience they knew the pipe was used to smoke marijuana and combined with the strong odor coming from the vehicle, they advised this officer.</p> <p>I approached the vehicle and noticed a w/f ( later I.D. as Sara J. Perterseil ) still sleeping in the back seat. I woke her up and asked her if she resided in the development. Perterseil stated she did not live there, but she lives in Palm Beach Gardens. I asked her what her address was and she advised she used to live at 2555 PGA Blvd. lot 81, but she just broke up with her boyfriend and no longer lives there. I asked her if she had anything in the vehicle I should know about and she hesitated. I asked her if I could search the vehicle and she stated " I'd rather you not. I then looked through the vehicle's window and also saw the glass pipe in plain view ( used to smoke marijuana ) on the drivers side door.</p> <p>Due to the facts above, I advised her that I had probable cause to search her vehicle and located the glass pipe in a red cup on the drivers side door, also on the drivers side door, I located a small plastic baggy filled with a white powdery substance I believed to be cocaine. While I continued my vehicle search, Ofc. Huba arrived and read</p>




The red cup which had the glass pipe also had marijuana residue on the bottom and a empty baggy.							
F	Due to the facts above Peterseil was placed under arrest for 893.13(1) Cocaine drugs possession of cocaine and 893.147(1) Drugs -Possess and/or \use drug paraphernalia. Peterseil was transported to the Palm Beach Gardens Police Department then the Palm Beach County Jail.							
P	The white powder was tested using the cocaine quickcheck test and tested positive for cocaine. the cocaine was weighed at .3 grams and placed into evidence with the rest of the drug paraphernalia.
