I then asked her for her driver's license, registration and proof of insurance which she could provide all the required documents. While speaking with Rudes I could smell a strong odor of an alcoholic beverage emanating from her person, her eyes were blood shot and glossy and she was slurring her speech. I then asked her if she had been drinking tonight and she stated that she had a drink and a half. Ofc Kenniston arrived on scene as my backup.</p> <p>I then asked her to exit the vehicle and I walked her over to the front of my patrol car. Based on my observations I asked Rudes if she would submit to roadside sobriety tasks to dispel my alarm that she was under the influence. Rudes advised that she would submit to roadside tasks. I then walked her over to a well-lit area and asked her if she had any medical problems or medical issues that would prevent her from doing the tasks. Rudes advised that she had no medical or physical issues that would prevent her from conducting the tasks. Rudes asked what would happen if she refused to do the tasks and I advised her of the Taylor Warnings. I then asked her if she would submit to the tasks and Rudes advised she would do the tasks. The tasks that were conducted were the Walk and Turn, One Leg Stand, Finger to Nose, and the Rhomberg Alphabet.</p> <p>The first SFST was the Walk and Turn. Rudes started before being told to begin and failed to walk heel to toe at any of the steps instead she took regular steps as she walked the line. She also made an improper turn by just turning around instead of the way that was demonstrated to her. Rudes took 17 steps forward and 23 steps back and she never counted any of the steps throughout the task. After finishing the task, I asked</p>

Rudes if she understood the instructions and she stated yes. I then asked her how many steps did I tell her to take and she stated 8 or 9.



The second SFST was the One Leg Stand. Rudes started the task before being told to begin the task. She failed to keep her foot six inches off the ground. She put her foot down during the task and she was swaying during the task. Rudes also didn't count the way that she was instructed.

The third SFST was the Finger to Nose (L-R-L-R-R-L). Rudes touched the tip of her nose and started to bring her hand down and then brought it back up and touched her nose again on the first left. The first right she touched the bridge of her nose. The second left she touched the tip of her nose with the pad of her finger. On the second right she touched the bridge of her nose. On the third right she started to raise her left hand up, but she corrected this action and brought her right finger up to her nose. On the third left she touched the top of her nose and used the pad of her finger. She was also swaying during the task.

The fourth SFST was the Rhomberg Alphabet which she couldn't recite properly, she advised that she forgot the last few letters of the alphabet. Based on my investigation I placed Rudes under arrest for DUI. Ofc Murphy searched Rudes and I then transported her to BRPD.

Ofc Reissi responded as my Breath Test operator. Ofc Reissi and I conducted the 20-minute observation and then she was taken into the BAT room. Rudes provided two valid breath samples of .129 and .123. I also read Rudes her Constitutional Warnings which she advised she understood and she started to answer questions but then refused to answer my questions without an attorney present. See DUI influence report.

Rudes is being charged under F.S.S. 316.193(1) for DUI. She is being issued a citation under F.S.S 316.123(2a) for the stop sign violation. Rudes was transported to Palm Beach county jail for final disposition. Rudes allowed Hernandez to take her vehicle.






