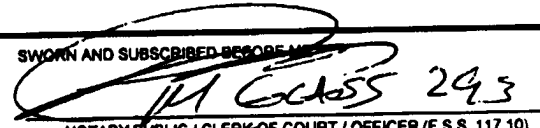

PALM BEACH GARDENS POLICE DISPATCH RECEIVED A CALL FROM A AN ANONYMOUS CALLER WHO WAS ADVISING OF A SUSPICIOUS FEMALE WITH NO SHOES WALKING AROUND THE AREA AND WHO APPEARED TO BE SCARED. UPON MY ARRIVAL I LOCATED A FEMALE FITTING THAT DESCRIPTION WALKING EAST BOUND ON GOLFERS CIRCLE EAST. I APPROACHED THE FEMALE INFRONT OF 4278 GOLFERS CIRCLE EAST. THE FEMALE STATED THAT SHE WAS AT A MALE FRIENDS HOUSE ON LILAC STREET, WHEN HIS WIFE ARRIVED HOME AND SHE HAD TO QUICKLY LEAVE THE RESIDENCE BEFORE SHE SAW HER. SHE RAN OUT OF THE HOUSE WITHOUT HER SHOES ON. THE MALE WAS GOING TO PICK HER UP SHORTLY AFTER HE LEFT THE RESIDENCE. THE FEMALE PROVIDED ME WITH HER PASSPORT, WITH A NAME OF ROMAN, SARAH M 4/11/80. A COMPUTER CHECK ON ROMAN REVEALED A PALM BEACH COUNTY WARRANT FOR FAILURE TO APPEAR (WARRANT # 17012136). ROMAN WAS PLACED UNDER ARREST. SEARCH INCIDENT TO ARREST AN INVENTORY OF ROMAN'S PURSE WAS CONDUCTED. DISCOVERED IN A MULTI COLORED COACH MAKEUP BAG WAS A CLEAR PLASTIC POUCH CONTAINING A WHITE CRYSTAL SUBSTANCE. DUE TO MY TRAINING AN EXPERIENCE I BELIEVED IT TO BE METHAMPHETAMINE. ROMAN WAS TRANSPORTED TO THE PALM BEACH GARDENS POLICE DEPARTMENT. THE CRYSTAL WAS FIELD TESTED INDICATING A POSITIVE RESULT AND WEIGHED IN AT 25.2 GMS. METHAMPHETAMINE WAS PLACED INTO EVIDENCE.
