Michael stated that he received a call from Sarah at approximately 2327 hours stating that she was going to "blow everything up". Michael stated that she then arrived at his house and began to ring the doorbell and would not stop. Michael stated that he had his children in the house and did not want Sarah there. Sarah began to call him several times and Michael told her that she was not allowed there and he wanted her to leave.</p>										
<p>I then made contact with Sarah who had a strong odor of alcohol and a slurred speech. Sarah stated that she was trying to talk to her boyfriend Michael but he wouldn't come outside. I advised Sarah that Michael did not want her there and she needed to find a ride because she was unable to drive. Sarah then began to yell stating "what the fuck, we have been together for 3 years" I again advised Sarah that she needed to find a ride and leave the property because Michael did not want her there. Sarah stated that she could not find her phone and did not have money to call a taxicab. I attempted to assist Sarah in finding her phone and it was not in her vehicle. Sarah then began to yell stating "he has my phone", I ask Sarah several times to lower her voice Sarah began to yell again "it has been 3 years". I made several attempts to have Sarah leave the residence in which she responded "it has been 3 years".</p>										
<p>I attempted to place Sarah under arrest in which she pulled away, I gave Sarah verbal commands to stop resisting, Sarah began to yell and threw herself on the ground and placed both hands under her chest. I again gave Sarah verbal commands instructing her to put her hands behind her back. Sarah then complied, I was able to handcuff her by placing both hands behind her back checking for proper tightness and double lock.</p>
