
On November 16th, 2017 at approximately 2151 hours I responded to the area of High Ridge Rd and West Gateway Blvd in reference to a hit and run that just occurred at this location. Prior to my arrival, Boynton Beach Police dispatch advised the vehicle was described as a possible Green Jeep bearing Florida tag GARI40.

Upon arrival I made contact with the victim who was later identified as W/F Villatoro Velasquez, Yessica (10/23/1996). Velasquez stated that while completely stopped at the solid red traffic control device, at the intersection of W. Gateway Blvd and High Ridge Rd, the rear of her blue 2012 Honda (FL/Tag HRMX52) was struck by the above mentioned vehicle. Velasquez, stated that she made contact with the driver and described the driver as a white female, wearing a possible purple shirt and dark blond/brown hair. Velasquez stated that the driver stated that the damage isn't that bad and that it was just "rust"; and then left the scene traveling eastbound on W. Gateway Blvd. After inspection Velasquez's vehicle, I noticed that it had minor chipped damage to the paint of the rear left bumper.

While on scene, officers patrolled the area of the last known location of the suspect vehicle. As a result, Officer Barrios located the suspect vehicle approximately 1.5 miles away from the scene of the crash and conducted a traffic stop at the intersection of Lake Shores Dr and N. SR 5. Upon my arrival, I observed the vehicle and driver that Velasquez had described to me. Further inspection of the Jeep I noticed small blue paint chips on the front right corner of the bumper; making Velasquez statement consistent to identifying the vehicle. I made contact with the driver, who was identified as W/F Lewis, Sarah (07/10/1988). After explaining to Lewis the reason for the traffic stop she first denied being involved in a crash then advised that there was no damage to her vehicle so she left. A show up was conducted by Velasquez, positively identifying the vehicle and Lewis. It should be noted that Velasquez stated that she is 7 months pregnant and requested to be seen by Boynton Beach Fire Rescue, reference to back pain as a result of the accident. After being treated, Velasquez refused to be transported to the hospital by fire rescue and advised that she would transport her self at the time.

Based on the above, Lewis was removed from her vehicle, placed into handcuffs (D/L and Spaced) and charged with 1F count of Leaving the Scene of a Crash with Injuries pursuant with F.S.S. 316.027(5)(a). Lewis was transported to the Boynton Beach Police Department for processing and later TOT PBCJ.
