On the above listed date/time I responded to 21211 Escondido Way reference a domestic disturbance. Upon arrival I made contact with victim, Benjamin Trawinski in the street in front of the residence. Benjamin had a what appeared to be a 3/4 inch laceration on the outside of his left forearm which was bleeding profusely. Benjamin refused to provide me with any information relating to what happened and only kept repeating he needed medical treatment. Palm Beach County FR #57 (17134091) responded and transported Benjamin to West Boca Medical Center reference stitches for his injury. I later made contact with his wife of eleven years, Sarah Valdes inside the residence. Valdes stated she was standing in the kitchen with Benjamin when they engaged in a verbal dispute. Valdes stated Benjamin was speaking very cruel to her and calling her names. Valdes stated during the argument she lost her temper, grabbed a knife from the counter. Valdes stated she lashed out with the knife striking Benjamin on the forearm. Valdes then stated a struggle ensued. Valdes stated Benjamin restrained her, forced her to the floor and took the knife from her. Valdes stated Benjamin then went outside. During the struggle Valdes sustained a small contusion on the right side of her forehead and left cheek. Valdes stated these injuries occurred after Benjamin was cut. Photos were taken of Valdes' injuries. I observed what appeared to be splattered blood on the kitchen floor. I also observed several knives on the counter however I was unable to determine which knife was used due to Valdes stating she couldnt remember which one she grabbed. Photos were taken of the kitchen. Based on the above information Valdes was placed under arrest for Aggravated Battery (Domestic). Handcuffs were checked for tightness and double locked. Valdes was later transported to The County Jail without incident.
