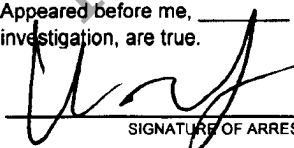
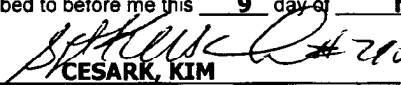

Officer Luciano made contact with the black male who at the time of my arrival, was being pushed by the white female. The male refused to provide his identification and actively resisted officers on scene. The black male was subsequently arrested and taken in custody during which time he further resisted officers and obstructed all investigative efforts of law enforcement on scene. The black male appeared to be reaching for something in his waistband or front pockets. Further investigation and search yielded a clear plastic baggie containing a white powdery substance which through my training, knowledge, and experience, I identified to be suspect cocaine. Additionally, I located a second clear plastic baggie containing suspect cocaine that the black male was attempting to conceal with his shoe. The black male was ultimately identified by his Florida issued driver's license to be James D. Emerson. Please see Officer Luciano's supplemental report for further.

I made contact with the caller, Hugh Walker, who provided a sworn statement advising the following: he observed the physical altercation between the male and female and stated the female (Spall) was the primary aggressor. Walker advised Spall punched Emerson in the face with a closed fist and followed him around yelling, screaming, and shoulder bumping him. Walker further stated that Emerson was not fighting back at all, "he was just walking away, looking at his phone trying not to fight back."

I observed Emerson to have visible abrasions to the middle of his forehead, the right side of his face and his right arm. He also had what appeared to be bleeding scratch marks on the right side of his neck, which appeared to be caused by Spall's nails. Emerson also showed evidence of swelling on the right side of his face which appeared to be caused by a closed fist punch to the face. When asked how Emerson sustained his injuries he stated "she (Saylor Spall) did this to me, she attacked me."

I made contact with Saylor Spall who simply advised "nothing happened" and refused to further comment on how Emerson received his lacerations.

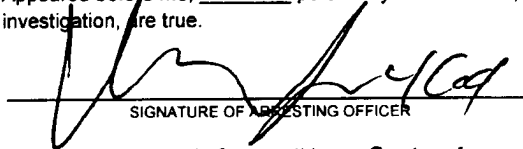
The suspect cocaine was tested with a Nark II Duquenois-Levine Reagent test kit and tested positive for the presence of cocaine. The suspected cocaine was packaged and submitted into Palm Beach Gardens Evidence.

Based on the results of my investigation and totality of circumstances, I find probable cause to charge Saylor Spall with Simple Battery, Touch or Strike, (Domestic) in accordance with Florida State Statute 784.03(1)(A)(1).

Additionally, I find probable cause to charge James Emerson with resisting arrest/ obstructing a criminal investigation in accordance with Florida State statute 843.02. I also find probable cause to charge Emerson with possession of controlled substance without a prescription in accordance with Florida State Statute 893.13(6)(A).
