PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

While on a traffic stop (in my vehicle) on the Northbound right shoulder at 14500 US Highway 1, Juno Beach, I observed a white Ford Ranger bearing FL tag DBYI58, traveling North past my location in the left lane. I visually estimated that the vehicle was traveling about 60MPH in a 45MPH zone, when it passed me. I activated the front radar in vehicle 114 (SN: EB001511), in stationary mode. The unit emitted an audible tone that was clear and consistent with the speed displayed on the screen, which was 57MPH. While still in my vehicle on the traffic stop, I observed the white Ford Ranger was still traveling at about the same speed, and it was approaching a solid red signal at US Highway 1/Juno Ocean Walk (14750 US1), Juno Beach, where another car in the same lane was stopped. The brake lights on the white Ford did not illuminate until the vehicle was very close to the intersection, and the vehicle did not stop quickly enough, causing the front of the white Ford to collide with the rear of the red Toyota Prius (FL tag Y38LFL) that was stopped for the red signal. I then saw the reverse lights on the white Ford come on. I quickly concluded my traffic stop and proceeded to the crash, at which time, I observed the white Ford rolling away slowly, and the front wheels turning, as if the driver was trying to leave. When I asked the driver of the Prius if the other driver had tried to leave already, she stated that he was trying to leave, after stepping out of the vehicle, and saying "Sorry" and "It was my fault". The driver/sole occupant of the white Ford was identified by FL DL as Scott A. Geltman. There was only minor damage (scratches) to the rear bumper of the Prius and no visible damage to the Ford Ranger.

OBSERVATION OF DRIVER:

Upon arriving at the crash, Geltman was in the driver's seat of the white Ford and was trying to pull away. When I came up and spoke to him, I noticed his eyes were bloodshot and watery, and he seemed to only keep his eyes open about halfway, as if he was tired. I also smelled a strong odor of an unknown alcoholic beverage being emitted from within the vehicle. After having both vehicles pull into the Shell Gas Station, I requested to see Geltman's insurance card, he provided me with his registration, and when I told him that, he kept saying that it was insurance. When I told him I needed to see his insurance card again, he started to walk toward his truck to get it, even though I saw that he had it in his hand. I also noticed that in general, he made slow movements. While the driver was outside of the vehicle, I smelled a strong odor of an unknown alcoholic beverage being emitted from his breath and person.

DRIVER'S STATEMENTS:

Geltman was advised I was now conducting DUI investigation and was read Miranda Rights on scene. He said he was coming from the Thirsty Turtle (a bar/restaurant in Juno Beach) and that he had one beer with his girlfriend. He also stated that the crash was his fault and that he slid into the car while trying to stop. Geltman's speech was slow and slurred, and he repeated multiple statements and questions throughout the encounter.


ODORS:

WALK AND TURN:

During the instruction phase, Geltman swayed and put his right foot (front foot) to the right to remain stable. During the walking phase, Geltman swayed, conducted an improper turn, and missed heel to toe multiple times (by about 2-3 inches).

CAN NOT DO, WHY? N/A

ONE LEG STAND:

Started before he was told to do so, held his hands approximately 2-3 inches from side, put his foot down, and did not count properly.

CAN NOT DO, WHY? N/A

FINGER TO NOSE:

On first left touch, he used the tip of his left index finger to touch the middle of his nose. One the first, second, and third right touch, he used the left side of his right index finger touch the tip of his nose. Each time he touched his nose, he held his finger to his nose for an extended period of time, even though he was told to put his finger down immediately, both at the beginning if the task, and after each touch. While conducting the task Geltman was swaying slightly, in a circular motion.

CAN NOT DO, WHY? N/A

ROMBERG/ALPHABET:

Geltman said the alphabet correctly, but did not close his eyes as instructed, and was swaying slightly, in a circular motion.
