<p>On Saturday, 09/17/2016 at approximately 1658 hours while working an overtime detail in the 300 block of Clematis Street, I was approached by a male witness who stated that a White male just broke a mirror on a vehicle.</p> <p>The unidentified witness stated that the White male was walking toward me. I exited my vehicle and the witness pointed out a male wearing a Grey T shirt and dark pants and he had just passed by me walking East by Grease.</p> <p>I walked up behind the White male, later identified as Scott Allert and grabbed on to his shirt and he turned around and looked at me. It should be noted that I was wearing a full Police uniform with POLICE in large letters on the front and back of my uniform. I ordered Allert to turn around and come back to speak with me in reference to the incident. When I grabbed on to Allert's shirt, he turned around and said "what the hell" and pulled away from me. I then grabbed onto one of his arms and he again pulled away from me, attempting to break free from my hold. I re-gained a hold to one of Allert's arms and escorted him to the ground and then placed him in handcuffs.</p> <p>Contact was then made with the victim, Marcella Ritchie. She provided a sworn recorded statement that was captured on bodycam and stated that while she was traveling with her daughter, Mekhia Powell on N Olive Avenue, Allert and a female acquaintance of his were walking East on Olive Avenue and crossed N Olive Avenue while the traffic light was green. Ritchie stated that she honked her horn as the two were in the moving lane of traffic. Ritchie slowed her vehicle to a stop due to Allert standing in the roadway. Ritchie said that Allert looked and starred at her and purposely walked slowly to make her wait at a stop longer. Ritchie then stated that Allert approached the passenger side of her vehicle where Powell was sitting and punched at her vehicle, making contact with her passenger side mirror. Ritchie checked her vehicle and stated that it did not appear to be damaged from what she could tell. She did not wish to prosecute for the</p>

mirror, but did provide a statement in reference to what occurred.

Powell was also interviewed on bodycam and she gave the same version of what occurred and stated that she was scared when Allert punched the mirror and was afraid of what he was going to do.

Allert stated that he was at Grease for the FSU football game, which began at 12 noon. Allert exhibited many signs of intoxication, uncluding slurred speech, stumbling while walking, aggressive behavior and bloodshot eyes.

Based on the above facts, probable cause exists to charge Allert with disorderly intoxication and disorderly conduct under Florida State Statutes.

It should also be noted that as Allert was sitting in the rear of my patrol vehicle as I was typing up the paperwork, Allert struck his head intentionally on the partition of my patrol vehicle, causing a laceration approximately 2.5 inches long to his forehead. Allert then began spitting the blood all over the back seat of my patrol vehicle and all over the partition as it ran down his face. He even made the comment "have fun cleaning your car". Your affiant requests that Allert pay for the Police vehicle to be professionally cleaned.
