PERSONAL CONTACT

NARRATIVE:

On 12/22/2017 at approximately 1327hrs I was dispatched and responded to [REDACTED] in reference to a domestic disturbance call, the call to police was made by a neighbor. The neighbor stated to dispatch that she heard screaming and crying coming from the above address.

Upon arriving I made contact with a Hispanic female, later identified as, [REDACTED], that was standing outside the house. [REDACTED] appeared visibly distraught and was crying. I asked [REDACTED] what had occurred and she stated that [REDACTED] had grabbed her by the hair and arm. [REDACTED] stated they had argued over his excessive drinking. [REDACTED] stated [REDACTED], Scott M. Behm, had been drinking all day and when they were standing in their bedroom she grabbed his bottle of Vodka off the dresser. [REDACTED] stated that Behm then grabbed her by her hair as she attempted to exit the bedroom. [REDACTED] stated Behm then grabbed her left arm and pulled her back. [REDACTED] stated she then ran out of the bedroom and to her neighbor's house.

I asked [REDACTED] if Behm had any weapons in the house and she stated he did own a gun. Ofc. Hagg # 157 and I approached the front door; I had my department issued Glock 40 drawn. I opened the front door and announced our presence. A white male exited the bedroom and I ordered him to slowly place his hand above his head, he complied. I ordered Behm to walk slowly toward the door and step outside, he complied. Behm was then cuffed to his rear and searched for possible weapons, with negative results. Behm cuffs were checked for proper spacing and double locked. Behm appeared to be intoxicated and had a slurred speech. Behm also had the odor of what smelled like alcohol emanating from his person. I asked Behm if he had any medical conditions and he stated he did not. Behm was placed in the rear of my marked patrol vehicle, while I made contact with [REDACTED] to observe any possible injuries.

I stepped into [REDACTED]'s bedroom and she removed her long sleeve shirt to show me where Behm had grabbed her arm. I observed a red mark that appeared to be consistent with finger impressions on her left upper arm area; near her bicep. Photos were taken and later placed into evidence. [REDACTED] had no other visible injuries and refused medical attention.

I spoke with Behm and asked him if he knew how [REDACTED] had gotten the mark on her arm and he stated he did not know. Behm then stated that he was upset because [REDACTED] wouldn't shut up and she had taken his Vodka bottle. Behm refused to give any further details.

[REDACTED] completed a Sworn Written Victim Statement and a Victim Notification Form. [REDACTED] did not want to give a recorded statement.

Behm was arrested and charged with Domestic Battery in accordance to F.S.S. 784.03 (1)(a)(1).

Behm was transported to Palm Springs Police Department for the completion of the appropriate paperwork and was later transported and turned over to Palm Beach County Jail.

Behm stated that he was upset because [REDACTED] wouldn't shut up and she had taken his Vodka bottle. Behm refused to give any further details.
