

On the **12** day of **February**, **2018** at **00:13** (Specifically include facts constituting cause for arrest.)

On 02/11/2018 at approximately 2129hrs, while conducting a crime prevention operation at 1133 North Alternate A1A, investigated a suspicious vehicle resulting in two arrests.

I was patrolling Sawfish Bay Park in my marked Jupiter Police patrol vehicle [#1608] when I noticed an open beer sitting out of a Blue Dodge Neon bearing [FL#:1490UI] near the rear passenger tire. Let it be noted that Sawfish Bay Park is a park in which alcohol is not permitted, per the laws and ordinances clearly posted at the entrance of the park. I then noticed the passenger, later identified as [Scott C Purnell;W/M;04/24/67] quickly exit the passenger side of the vehicle and attempt to act as like he was not consuming alcohol. To address the violations I then advised dispatch I would be making contact with the vehicle and the occupants and then approached the vehicle on foot on the passenger side. I then made contact with Purnell and the male in the drivers seat later identified as [Daniel W Keller;W/M;12/14/68]. Inside of the vehicle I noticed numerous open containers of alcohol inside of the vehicle on both the driver and passenger sides.

Purnell was able to provide identification in a prompt manner but when I asked Keller for identification he was unable to locate it in his wallet which was on his person. Keller then leaned back over the drivers seat and searched through his bag containing numerous food and garbage items. It took Keller a while to eventually find his identification and at this time I noticed Keller unbuckle his chained wallet from his person and attempt to hide it. I then walked back to my vehicle to input both occupants drivers license into my MCT for dispatch to conduct an FCIC/NCIC check on. Ofc. D. Zeitz then arrived on scene to assist with the investigation. Ofc. I then spoke with Keller at the driver side door and asked both male occupants verbal permission to search the interior of their vehicle for any illegal contraband. At first Purnell stated "I mind, I don't want you inside of my car"[sic] but before I could rebuttle he said "you know




what go ahead"[sic] and was then asked to exit the vehicle. A pat down was conducted on Purnell which yielded negative results . Next, a pat down was conducted on Keller which yielded negative results and at this time Keller did not have his wallet on him.

An interior search of the vehicle was conducted at which time I located a small clear plastic baggy containing a white power substance [2.69gms] underneath the drivers seat where Keller was seated. I then located a charred clear and black smoking devices, with residue, used for smoking cocaine underneath the passenger seat where Purnell was seated. During this time Ofc. D. Zeitz issued both their Miranda rights in which both verbally acknowledged. Before searching the rest of the vehicle I spoke with Purnell and Keller about my findings inside of the vehicle. Purnell then stated "its all mine"[sic] in regards to the pipe and suspected cocaine. I then asked him if it was cocaine, but he denied it, stating that "its just baking soda"[sic]. He went on to state that he does use drugs and uses the baking soda to cut it with. An on scene NIK kit test did not determine that the white powdery substance was cocaine but it will be sent to the PBSO laboratory for further testing. I then returned to searching the rest of the vehicle and located the chain wallet which was attached to Keller in the vehicle underneath the passenger seat in a gray shopping bag. I then opened the wallet and found a zipper compartment and located a white piece of paper. Inside of the piece of paper was what appeared to be a broken down pill into small rock size pieces [0.52gms]. I then questioned Keller on what it was at which point he stated "its subutex man"[sic], but due to the size of the pills and inability to identify the substance(s) on scene he was placed under arrest for the Possession of a controlled substance without a prescription and tampering with evidence. After being arrested, Keller then stated he might be able to locate the prescription in his bag in the back of the car but did not let me know upon contact he had the pill(s) in his possession and made an effort to hide/conceal it. Let it be noted that I did conduct a search of Kellers bag and was unable to locate any form of paperwork regarding the prescription.

Both subjects were then placed under arrest and into handcuffs [Double Locked & Safety Gapped] and placed info the rear of my patrol vehicle. Ofc. D. Zeitz completed the vehicle tow sheet as the park closes at midnight and the vehicle was inventoried, secured and turned over to East Coast Towing. Both subjects were then transported to the Jupiter Police Department where upon their arrival they were booked and processed in accordance with departmental policy. Upon completion they were then transported and turned over to the Palm Beach County Sheriffs Office. The illegal contraband recovered was secured on scene and later logged into the Jupiter Police Departments evidence section. Both subjects were given writtes warning for the bevrage violations, an FIR was completed on the incident and my BWC was utilized.
