NARRATIVE:

On Sunday 4-3-16 Palm Beach County Sheriff's Office (PBSO) Communications received a call from complainant [REDACTED], was texting him she was drugged and "raped." [REDACTED] she was at the suspect's house and his name was Scott Strolla. Palm Beach Gardens Communications transferred a 911 call from [REDACTED] to PBSO Communications. [REDACTED] said she was hiding in a bush, she just got "raped," she thinks she was drugged, and she was very scared. [REDACTED] told the dispatcher she was on Treasure Island Drive.

On 4-3-16 Deputy Perez I.D. #14622 responded to 13412 Mangrove Isle Drive. While he was driving on Treasure Isle Drive, [REDACTED] ran toward him crying and screaming. She said she was "raped," by Scott Strolla.

[REDACTED] was taken to the Butterfly House at Wellington Hospital where a Sexual Battery Evidence Collection Kit (SBECK) was completed.

Detective Saint Jean I.D. #8192 responded to the Butterfly House and conducted an interview with [REDACTED]. [REDACTED] stated she went to Lynora's on Clematis Street with her friends [REDACTED]. [REDACTED] was approached by Scott Strolla, who said he recognized her as one of his Facebook friends. Scott purchased several drinks for her, and offered [REDACTED] and [REDACTED] some of his breakfast pizza, which they ate. Scott invited them to go with him and some friends to a nearby bar called Sketch. While at Sketch Scott purchased [REDACTED] another alcoholic drink and shortly afterward she felt nauseous. [REDACTED] ran to the restroom and vomited on the floor because she lost all control of her body and could not hold it in. [REDACTED] said she has

never felt that physically ill before. [REDACTED] remembered waking up at Scott's house with Scott on top of her with his penis inside her vagina. She recalled feeling paralyzed and not able to move. [REDACTED] could hear clicking sounds like a camera, and she could see the flashes of light. She felt Scott spreading her legs apart, pulling her underwear to the side, and pulling her bra/top down. When she was finally able to wake up [REDACTED] could not understand what she was doing at Scott's house. She sent text messages to [REDACTED] told him she was "raped," she needed help and to call 911. [REDACTED] told Scott she was calling an UBER (cab) and ran out of his front door, down the street, hid in the bushes and called 911.

On the morning of 4-4-16 Detective Saint Jean and I went to 13412 Mangrove Isle Drive where we conducted an interview with Scott Strolla. Scott provided the following information. Scott knew [REDACTED] (who he refers to as [REDACTED] because they had mutual friends and they were previously connected via Facebook. On 4-3-16 Scott met with friends at Lynora's Restaurant. Scott ordered a breakfast pizza and noticed [REDACTED] and her friend [REDACTED] at the end of the bar. He brought them each a slice of the pizza and told the bartender whatever the girls opted to drink would be on his tab. He returned to his group of friends and [REDACTED] and [REDACTED] came over and were socializing with Scott and his group. [REDACTED] began holding his hand and kissing him. Between 3:30 and 4:00 p.m. Scott, his friend [REDACTED] and [REDACTED] went to Sketch. Shortly after arriving at Sketch [REDACTED] told Scott she was not feeling well. [REDACTED] helped [REDACTED] into the bathroom and he assumed she went to vomit. Scott said [REDACTED] did not appear impaired. She was coherent, not slurring her speech, and able to walk up and down stairs coordinately. He had no reason to believe she was unable to make clear decisions. At approximately 6:00 p.m. Scott, [REDACTED] and [REDACTED] left Sketch together and [REDACTED] advised [REDACTED] she was too intoxicated to drive. Scott drove [REDACTED] to his home; they went inside and upstairs to the master bedroom. [REDACTED] kept her underwear and bra on and she got into his bed underneath the covers. Scott changed into boxer shorts, got into the bed with [REDACTED], and began kissing her all over her body. Scott kissed [REDACTED] on her vagina, underneath her underwear. He stated [REDACTED] received a text message and told him she had to leave immediately. Scott offered to drive [REDACTED] back to her vehicle but she declined and said she would catch an Uber car service. Scott stated he did not have sexual intercourse with [REDACTED] and he denied photographing [REDACTED] at his house.

On 4-4-16 a search warrant was executed at Scott Strolla's residence. During the search a Samsung Galaxy S6 cellular telephone belonging to Scott Strolla was recovered and a search warrant was obtained for the phone contents. Detective Indovina I.D. #8204 completed forensic analysis on the phone which shows the following: photos taken on 4-3-16 of [REDACTED] vagina, breasts and buttocks while [REDACTED] was passed out and lying on Scott's bed.


Standard saliva samples were recovered from Scott Strolla pursuant to a search warrant. DNA Analysis was conducted by the PBSO Forensic Biology Unit on the contents of the Sexual Battery Evidence Collection Kit (SBECK). Scott Strolla's DNA cannot be excluded as a contributor to the major DNA profile for the DNA found on [REDACTED] vaginal and perineum swabs.

Based on the above information there is probable cause to believe Defendant Scott Strolla, a person eighteen years of age or older, did commit sexual battery upon Victim [REDACTED]

[REDACTED] a person 12 years of age or older, without [REDACTED]'s consent, by putting his penis inside the vagina of [REDACTED], and in the process thereof did not use physical force and violence likely to cause serious personal injury, contrary to Florida Statute 794.011(5) AND

Did for his own amusement, entertainment, sexual arousal, gratification, or profit, or for the purpose of degrading or abusing another person, intentionally use or install or permit the use or installation of an imaging device to secretly view, broadcast, or record a person, without that person's knowledge and consent, who is dressing, undressing, or privately exposing the body, at a place and time when that person has a reasonable expectation of privacy, contrary to Florida Statute 810.145(2)(a).
