 On the 5 day of May, 2018 at 11:44 (Specifically include facts constituting cause for arrest.)

On 05/05/2018, at approximately 1029 hours, I was in the area of North Military Trail and PGA Boulevard and observed a green Ford Ranger (FL Tag #503QTG) in the center lane stopped at the traffic light. I was positioned in the inside lane slightly behind the vehicle. I ran the license plate through FCIC/NCIC which revealed that the owner of the vehicle had a suspended license and the license plate had a seize tag order attached. I viewed the owners photo on FCIC/NCIC which I was able to confirm was in fact the person I observed driving the vehicle.

I conducted a traffic stop on the vehicle at North Military Trail and Kyoto Gardens Drive for violation of Florida State Statute for driving a motor vehicle with a suspended license based on the fact the suspended party was seen by me operating the motor vehicle.

Upon contact with the driver, identified as Sean Anthony Guzinski, I identified myself and informed him for the reason of the traffic stop. Guzinski informed me he did not know his license was suspended. As I returned to my patrol vehicle I issued Guzinski a citation for violation of Florida State Statute 322.34(1) Unknowingly Driving with a Suspended License. I requested a rotation tow truck (Kauff's) respond to tow the vehicle. This was due to the seize tag order on the vehicle. The tag will be turned in with the citation, and the vehicle can not be driven without a license plate.

I informed Guzinski of the citation and provided him his insurance back. I informed him that he was not able to drive, and he could call ride to pick him up. Officer Machado (#497) began to conduct an inventory of the vehicle prior to being towed. It should be noted Guzinski was free to leave and had all his possessions, he remained on scene while waiting for his ride.

I was informed by Officer Machado that he had found a vapor pen inside the vehicle. The

pen was located inside a black backpack that contained other items of Guzinski's. As I investigated the vapor pen I observed an orange oil inside the holding compartment. I attempted to move the oil to see if it would move and it did not. It appeared to be stuck in place. I was able to believe due to the fact the oil did not move, and the color was orange it did not appear to be nicotine oil. Based on my training and experience I believed it to be possible THC oil. This is also commonly referred to as "dab" "wax" or "oil". I field tested the oil inside the vapor pen which tested positive for THC oil. When I asked Guzinski if it was THC oil inside the vapor pen he replied yes.

At this point in time I placed Sean Anthony Guzinski under arrest for violation of Florida State Statute 893.13(6) (A) Drugs-Possession of Controlled Substance without Prescription for possessing THC oil inside the vapor pen. It should be noted that possession of THC oil is a Felony Offence in the State of Florida.


I issued Guzinski a citation for the original offence of DWLS W/O Knowledge, and a tracking citation for 893.13(6) (A) for the Possession of Drugs.

The vehicle was turned over to Kauff's Towing and the tow inventory was submitted into Records. I later submitted the vapor pen which contained THC oil into Evidence.

Guzinski was transported to the Palm Beach County Jail without incident.
