On the 22 day of September, 2019 at 01:20 (Specifically include facts constituting cause for arrest.)

On 9/22/2019, at approximately 0120 hrs, I was conducting a traffic stop in front of Jumby Bay bar (1203 Main Street). While at the driver's window, I heard a loud disturbance coming from behind me toward the bar area. I heard a female yell that she was going to get the police. When I looked to my right I observed Jumby Bay manager Seth Bennett (IO-1) being pushed by intoxicated bar patron Sean Denyse (DEFENDANT). I immediately cleared my traffic stop and advanced on Denyse to take control of the situation. Due to Denyse's level of intoxication, size, violent demeanor and the fact that I was alone, I held him at taser point and ordered him to prone out on the ground. Once he was proned out and I observed my backup arriving, I placed Denyse into protective custody.

Bennett advised me that Denyse had become highly intoxicated over the evening and was refusing to leave. Bennett advised me that once they got him outside of the establishment is when he became violent and started to push him, which is the confrontation that I observed. Bennett did not want to pursue any criminal charges in regards to being pushed. He issued Denyse a lifetime trespass from Jumby Bay (dispatch notified and FIR completed). Based on my observations and investigation, I have probable cause to believe that Sean Denyse was intoxicated in a public place and caused a public disturbance, contrary to F.S.S. 856.011. I transported him to JPD for paperwork and then booked him into county jail on one count of disorderly intoxication. BWC.
