

The driver was involved in a hit and run where he was found at fault. Ofc Counts ID347 stated that he watched the suspect vehicle go around the vehicle he had struck attempting to leave. Ofc Counts stated that the suspect vehicle saw Ofc Counts and came to an abrupt stop.

OBSERVATION OF DRIVER:

Fowler appeared disheveled and very uneasy on his feet. As I spoke with Fowler I observed that he had glassy, bloodshot eyes and a lazy gaze. Fowler repeatedly folded the papers in his hands restlessly appearing not to know what to do with them. I observed that Fowlers eyes were slightly shut most of the time.

DRIVER'S STATEMENTS:

As I spoke with Fowler he would repeatedly tell me, "Don't do this to me man" he would say this through out my interaction with him. Fowler stated that he was picking up his friend from Square (referring to Castaways Bar aka Square Grouper). Fowler told me that he had 2 beers this night. I asked Fowler on a scale of 1-10 how hammered he was and he said "Not that hammered."

ODORS:

Fowler had a very strong odor of an unknown alcoholic beverage coming from his breath and person.

Other Observations:

During the HGN task Fowler swayed back and forth in place. I had to repeatedly remind Fowler to keep his head still for the task. Fowler also showed onset of nystagmus vertically.

WALK & TURN:

Fowler was unable to stay in the position I instructed him to stay in as I was explaining the instructions. Fowler began the task before he was instructed to do so. While standing in position Fowler would lose his balance and would need to raise his arms. After Fowler stated that he understood the instructions he stood in place as he counted and failed to take any steps. I then explained the task one more time and demonstrated the task again. Fowler did not touch heel to toe for steps 1 through 9. Fowler had his arms raised away from his body as he was walking. Fowler did not turn as instructed. On the return steps Fowler stepped off the line on step 1. Fowler did not touch heel to toe for all 9 steps back.

ONE LEG STAND:

Fowler lifted his leg while I was giving instructions before I told him to start. Fowler lost his balance and placed his foot on the ground as he counted to 1011. Fowler picked his foot back up, counted to 1012 and placed his foot back on the ground. I asked Fowler to keep going until I tell him to stop. Fowler picked his foot back and began counting "13, 14, 15, 16, 17, 18". When Fowler got to 14 I was telling him he could stop but he kept counting to 18.

FINGER TO NOSE:

Fowler would sway back and forth as he was standing in position. Fowler tilted his back before beginning the task. I had to ask Fowler to tilt his head all the way back. L1 he touched the left side of his nose with the pad of his finger. R1 touched the left side of his nose with the pad of his finger. Fowler lowered his head. L2 he touched the bottom of his nose with the pad of his finger. R2, he touched the bottom of his nose with the pad of his finger. R3, he touched the bridge of his nose with the pad of his finger. L3, he touched the bottom of his nose with the pad of his finger.

ROMBERG ALPHABET:

I asked Fowler if he knew the alphabet and he would begin to recite it. Fowler tilted his head back before I told him to begin. Fowler would repeatedly begin to recite the alphabet before being told to begin. Fowler stated the following, "A, B, C, D, E, F, G, H, I, J, K, LMNOP, Q, R, S, T, U, V, W, X, Y, AND Z"

Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
