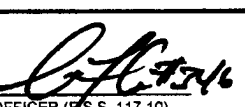

On the 22 day of June, 2019 at 16:54 (Specifically include facts constituting cause for arrest.) On June 22, 2019 at 4:54pm a 911 call was received regarding an indecent exposure call. The caller, [REDACTED] advised she was at the Burns Road Community Center Walking Trail, located at 4404 Burns Road, Palm Beach Gardens, Palm Beach County, Florida and saw a white male exposing himself to her in public. Officer Slaughter met with the complainant who reported the incident. The complainant advised the male left in a hurry in a newer silver Mazda SUV with a young boy in the vehicle. I, Detective Brashear, read the incident report and immediately thought of Sean Hayman due to him being a white male, 45 years of age with a 6-year-old son. Sean Hayman is a known sex offender who resides in Palm Beach Gardens. I have been overseeing his residency in the city for approximately 8 years. Hayman was arrested in Martin County for Lewd and lascivious exhibition which resulted in his sex offender status. A check of the Driver and Vehicle Information Database revealed Hayman owns a Silver 2013 Mazda which matches the description of the vehicle [REDACTED] described. There is video surveillance of Sean Hayman being at the Recreation Center on 06-24-19 at 4:35pm. On 06-25-19 I met with the complainant for the purpose of obtaining a sworn statement and she gave a detailed description of the indecent exposure. [REDACTED] advised she first noticed the man playing with the young boy. As the male was walking around, [REDACTED] believes that the male was looking at her aggressively and creepy. The male then disappeared for a moment and then came back without a child. When the male came back, he was swinging on the monkey bars and his buttocks was exposed

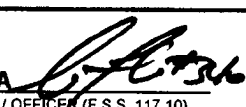
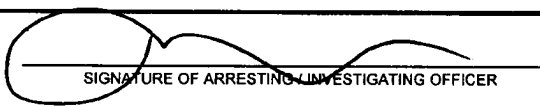

due to his baggy shorts being down, the male then pulled them up. [REDACTED] was uncomfortable but gave the male the benefit of the doubt that his pants fell down accidentally. She then noticed the male with his pants down again, purposely stretching in front of her fully exposing his penis and buttocks. The male made no attempt to pull his pants up and walked around the area with his pants down. [REDACTED] felt the male was purposely exposing himself to her. [REDACTED] called 911. The male walked around the gym equipment with his pants and under clothing down and then proceeded to walk to his car. This is when [REDACTED] noticed the child was in the backseat of the shiny silver Mazda. She believed he knew she was calling 911 because the male jumped into the vehicle and started to drive away with the back hatch open, not allowing her to see his vehicle license plate. On 06-25-19 Sean Hayman was arrested for indecent exposure. Post Miranda Sean Hayman admitted to being at the park with his son and then putting his son in his hot car while he returned to the workout equipment. Hayman advised there was a time or two that his pants slipped down and possibly exposed his "butt crack" but never did he expose his penis. Sean Hayman also admitted to driving away with his hatch open but claimed it was because he forgot to close it. While conducting my investigation, I found that [REDACTED] gave a sworn statement articulating that a male, identified as Sean Hayman, did expose his sexual organ in a public place where the public frequents. Sean Hayman (W/M D.O.B. 11-26-74) unlawfully did expose or exhibit his sexual organs in a public place, in a vulgar or indecent manner, contrary to Florida Statute 800.03. Sean Hayman was arrested and transported to the Palm Beach County Jail.
