
confessed to **OFC GREEN** admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the **29** day of **January**, **2018** at **22:40** (Specifically include facts constituting cause for arrest.)

At approximately 2122hrs on 01/29/18 I responded to Lynn University dorms in reference to an administrative search conducted by Lynn security. Upon arrival I made contact with Sgt. Ray Lauderback who had conducted the search of Sean Chatlani's dorm room.

Lauderback stated that resident assistant Mark Pryor alerted him that odor of marijuana was coming from 317. Once Lauderback arrived outside of room 317 he also noted the odor coming from the room. Security knocked on the door and informed Chatlani that they will be conducting an Administrative search of his dorm room due to the odor coming from it. When they initially asked Chatlani what the odor was coming from he stated that it was a George foreman grille. After speaking with Chatlani again Lauderback was able to get him to tell him where the paraphernalia was located in his room. Multiple grinders, pipes and storage containers containing residue were located on top of a personal refrigerator as well as inside Chatlani's bag cooler. One of the containers inside the cooler which was a rubber multicolored container had an orange/yellow colored tacky substance. Chatlani stated it was marijuana "concentrate". Lauderback gave a statement of the incident on a mobile video recorder.

Myself and Ofc. White arrived when Lauderback was searching the cooler. Security requested our presence inside the dorm to standby while they finished up the search. They had most of the items found during the search on a chair. Prior to speaking with Chatlani I read him his Miranda rights and he stated he understood them as I read them to him. Post Miranda Warnings Chatlani admitted that all the paraphernalia items were his and that the only marijuana he had was residue in some of the containers and bowls. Chatlani acknowledge that the container containing Hashish was his and that he knew what it was. Inside the dorm room the beds are situated in the same room which each student having their own belongings on each side of the room. According to Chatlani and Lauderback, the Hashish and paraphernalia were all Chatlani's items and in the area where he keeps his personal items. The Hashish tested positive for marijuana using a
