

I arrived at room 403 where Sean stated to dispatch he would meet us there. Sean was not on scene. I knocked on the door of room 403 where I made contact with Candice Ford (DOB 04/10/1989.) I observed Candice had a visible fresh contusion on her right cheek. Candice was clearly upset and crying. Candice spontaneously uttered to me that Sean had beat her up. I asked her if Sean had hit her in the face with a closed fist and she responded yes. Sean was not on scene. Attempts to call Sean back were met with negative results due to him having left his cell phone in the hotel room. Candice confirmed Sean as the person who had registered the room. Contact was made with Super 8 Motel clerk who provided a copy of Sean's license which was used to verify his identity. Candice stated that her and Sean had been boyfriend and girlfriend for six years and that they previously lived together within the past year. Candice stated that Sean owns a 2017 black in color GMC pickup truck that he had used to leave the motel and that Sean was intoxicated. A DAVID record check produced a 2017 black in color GMC pickup truck registered to Sean bearing Florida tag number HRJ J44.

LPD Officers BOLO'd the area for Sean or the vehicle with negative results.

I asked Candice to complete Lantana Police Department paperwork and she refused to sign or complete any forms. Candice also refused to let me photograph her injury and refused medical treatment.

The original call to Lantana Police Department was placed on the non emergency line by the Super 8 motel clerk and relating to the phone issue. Due to this no 911 recording was placed into LPD evidence.

A victims notification form and domestic diagram was completed without Candice's signatures or initials.

No witness on scene. No CCTV

Attempts were made to have Candice relocate in case Sean returned. Candice refused. All keys to the room were deactivated by Super 8 staff and Candice was provided one working key with instructions to call LPD if Sean had returned. At 0216 hours Candice called back stating that Sean was at the Mobile gas station located at 1510 Hypoluxo Road, Lantana, Florida, 33462. Officers BOLO'd that area with negative results. Contact was made Candice who advised she met Sean at the mobile and while with Sean she informed him that Lantana Police were looking for him. He then instructed her to get out of his vehicle and left again.


Due to the injuries sustained by Candice and her spontaneous utterances stating that Sean had battered her I believe there is enough probable cause to request a warrant for Sean's arrest. This case will be filed with the State Attorney's Office.
