license), whom was already speaking with Officer Schneider ID 330 in front of the residence. I introduced myself and asked her to explain to me what had transpired prior to our arrival.

My BWC captured the following and is not purported to be verbatim.

Ms. Vergara advised she had been out with her boyfriend, W/M Sean Quinn DOB 10/25/66 (which was later verified by Florida driver's license) earlier tonight and they had been drinking. Ms. Vergara advised Mr. Quinn's behavior at the Cigar Bar had been unacceptable and they began arguing on the way home. Ms. Vergara stated when they arrived home, Mr. Quinn went in to take a shower and she went in there to speak with him about his change in behavior as of recently. Ms. Vergara explained that Mr. Quinn went in to his son's room to go to bed but she was not finished speaking with him and followed him in to the room. Ms. Vergara advised she was sitting next to him on the bed, still trying to engage in conversation when Mr. Quinn swung his arm back and struck her in the face. Ms. Vergara advised he yelled at her as he was swinging his arm back but stated she did not believe it was intentional. Ms. Vergara advised the hit across the face knocked her to the ground. She advised she got upset and asked Mr. Quinn for assistance getting up from the floor, but Mr. Quinn refused to assist her and continued to lay in bed. Ms. Vergara advised she was having difficulty breathing and crawled out to the kitchen to get the telephone in order to call 9-1-1.

Ms. Vergara did appear to be intoxicated while speaking with her. Ms. Vergara had blood on her hands as well as her face but refused medical treatment on scene. Ms. Vergara was crying and stated several times she did not want Mr. Quinn to get in trouble but she did not know what to do once she realized she was having difficulty breathing.

I then made contact with Mr. Quinn inside of the residence, who was standing by with Officer Kolenich ID 314. I introduced myself and asked him to explain the events from this evening. Mr. Quinn stated he went to a few bars with Ms. Vergara earlier in the evening and alcohol was consumed. Mr. Quinn stated they had not been arguing on today's date but the last few months have been strained. Mr. Quinn stated they arrived home and after showering, he went to his room to go to sleep. I asked Mr. Quinn if sleeping in separate bedrooms was normal for their relationship or just tonight. Mr. Quinn stated he has been sleeping in his twelve year old son's room for the last few months. Mr. Quinn advised he was asleep for approximately an hour and a half when Ms. Vergara came in to the room and began yelling at him and "beating the shit" out of him. Mr. Quinn repeatedly denies striking Ms. Vergara or physically touching her. I did not observe any physical markings on Mr. Quinn that would be consistent with the level of physical altercation he expressed to officers on scene. Mr. Quinn at one point even stated he had no markings on him. Mr. Quinn suggested Ms. Vergara caused the injury to her face herself and stated she was not injured in the bedroom he was in. I asked Mr. Quinn to clarify his statements on the level of force Ms. Vergara used on him when she entered the bedroom. Mr. Quinn ultimately stated she did not beat the shit out of him but was more of an agitating manner than causing physical injury.

I asked Mr. Quinn to escort me to the bedroom he was located in when Ms. Vergara allegedly attacked him. While walking towards the hallway to the bedrooms, I observed a small blood droplet on the tile floor in the foyer area. The room was located on the southwest side of the residence and appeared to be a young juveniles bedroom. I observed blood pooling on the carpet and the bed appeared to have been laid in recently. Mr. Quinn could not explain how the blood got on the carpet and repeatedly stated he did not touch Ms. Vergara. I will note that Mr. Quinn was only wearing boxer shorts and appeared to have been laying down in bed on initial contact. Mr. Quinn's speech was slurred and he repeated his statements several times after being instructed to

explain the incident from tonight and not events that have happened in the past.

Based on the blood located in the bedroom Mr. Quinn was occupying, the facial injuries Ms. Vergara sustained and the inconsistencies in Mr. Quinn's statements, I find probable cause to charge Mr. Quinn with Simple Battery (Domestic) pursuant to F.S.S. 784.03(1) (A) (1).

I placed Mr. Quinn in handcuffs, checking for placement and proper fit. I doubled locked the handcuffs and escorted Mr. Quinn out to my marked Jupiter Police Department issued patrol vehicle (car #1503) and placed him in the backseat. I secured Mr. Quinn with a safety belt and escorted him to the Jupiter Police Department's holding facility to complete the proper paperwork. During our short travel from his residence to the police department, Mr. Quinn expressed his anger about the situation but followed up with understanding for me having a job to do. His mood swings would go from anger and agitation to understanding. Mr. Quinn instantly went back to sleep once he was placed in a holding cell, only waking to use the restroom.

Mr. Quinn was escorted to the Palm Beach County Jail without incident. I issued Ms. Vergara a Domestic Violence Rights and Remedies packet prior to leaving the residence. Officer Schneider took photographs of Ms. Vergara's injuries and the blood evidence located inside the residence with his department issued Axon cellphone. The photographs were uploaded to Evidence.com

Filing packet was completed. Nothing further at this time.
