**D.U.I. PROBABLE CAUSE AFFIDAVIT**

ON THE 25 DAY OF September 2016 AT 0226  A.M  P.M.

**PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:**

On the above date and time I responded to 744 W. Boynton Beach Blvd (7-11) in reference to a traffic stop conducted by Officer Grigorian. Let it be noted that this incident occurred within the City of Boynton Beach, Palm Beach County, Florida.

Upon arrival I made contact with Officer Grigorian who advised that while traveling eastbound on W. Boynton Beach Blvd (SR 804) in the 1400 block, he observed a White Chevy Tahoe bearing Florida tag CHBT99 traveling in front of him, in the center lane. Officer Grigorian advised that he estimated the vehicle to be traveling approximately 65mph in a 40mph zone. Officer Grigorian advised that by utilizing the pace method, he paced the Tahoe with his fully marked patrol vehicle at a constant speed of 60mph. Officer Grigorian advised that while pacing the vehicle, the vehicle failed to maintain a single lane as it was swerving into the inside and outside lanes of travel. Officer Grigorian advised that due to the traffic infractions, he activated his emergency lights and sirens and conducted a traffic stop on the vehicle at 744 W. Boynton Beach Blvd. Officer Grigorian advised that while making contact with the driver of the vehicle W/M Sullivan, Sean (05/11/81), he detected an odor of an alcoholic beverage emitting from his breath. Officer Grigorian advised that Sullivan's eyes were bloodshot/glassy and his speech was thick and slurred. Officer Grigorian advised that based on his investigation and observation he contacted me so that I could continue the investigation. See Officer Grigorian's supplement for further.

I then made contact with Sullivan, who was still sitting in the driver seat of the above vehicle. I identified myself to Sullivan and re-advised him the reason for the traffic stop, which he advised that he understood. I asked Sullivan where was he coming from, which he stated from getting something to eat. Sullivan further stated that he and his friend ate at Walmart. Knowing that Walmart does not serve food, yet alone at 0300hrs, I asked him what did he eat. Sullivan just stared at me with a blank stare. I asked him again, which he stated that he forgot. Sullivan then advised that after Walmart he and his friend began to drive around to look for an open place to eat. When I asked Sullivan, what places did he check; he just looked at me and stated that he did not remember. Sullivan appeared to be nervous while speaking with me. As Sullivan spoke, I detected an odor of an unknown alcoholic beverage emitting from his breath and within the vehicle. Sullivan's eyes were bloodshot/glassy and he spoke with a thick slur speech. To further continue my investigation, I requested Sullivan to exit his vehicle and walk to the front of my fully

marked patrol vehicle (4445), which he agreed to. While walking towards my vehicle, Sullivan swayed side to side. Once in front of my vehicle I advised Sullivan that the investigation was being audio and video recorded, which he stated that he understood. I advised Sullivan that I requested that he exited the vehicle due to that fact that I smell the odor of an alcoholic beverage emitting from his breath and within the vehicle. Sullivan advised that it wasn't coming from him but his passenger. I asked Sullivan if he any type of alcoholic beverage tonight, which he stated no. I asked him if he had any throughout the day, due to the fact that I can smell it, which he stated no. Therefore I requested Sullivan to submit to a series of Road Side Sobriety Task, which he agreed to. Let it be noted that prior to starting the exercises I asked Sullivan if he had any injuries and/or disabilities which he stated no. See the following:

**WALK AND TURN:**

The Task was explained and demonstrated to Sullivan, which he stated that he understood. During the instructional stage, Sullivan had a difficult time standing in the manner I requested of him. Sullivan swayed side to side. During the walking stage, Sullivan took 9 steps forward missing heel to toe between steps # 1-2, 2-3, 4-5, 5-6, 6-7, 7-8, 8-9. Sullivan completed an improper turn. Sullivan took 9 returning steps, missing heel to toe between steps #1-2,2-3,3-4,4-5,6-7,7-8,8-9. Sullivan did not count his steps out loud.

**ONE LEG STAND:**

The Task was explained and demonstrated to Sullivan, which he stated that he understood. During the instructional stage, Sullivan sway side to side. Sullivan raised his right foot up and counted to # 25.

**FINGER TO NOSE:**

The Task was explained and demonstrated to Sullivan, which he stated that he understood. During the instructional stage, Sullivan sway side to side. During the exercise stage, on the first "left" command Sullivan raised his left hand directly to his side for approximately 3-4 seconds then touched the bottom of his nose. Sullivan missed the tip of his nose on the first and second "right" command. When given the third "right" command, Sullivan utilized his left hand. When given his third "left" hand, Sullivan used his right hand. Sullivan failed to return his arm to his side after every command.

**ROMBERG/ALPHABET:**

The Task was explained and demonstrated to Sullivan, which he stated that he understood.

During the instructional stage, Sullivan sway side to side. Sullivan advised that he did not feel comfortable reciting the alphabet, therefore I had him count from 46-76; which he agreed to. During the exercise stage, Sullivan miss counted.

Based on the above facts Sullivan placed into custody under suspicion of DUI, which he stated that he understood. Sullivan was placed into handcuff (D/L and Spaced) and placed in the back seat of my patrol vehicle (#4445). While attempting to place Sullivan in my vehicle, he refused to comply. I had to repeat to Sullivan to "stop resisting", as I told Sullivan to enter to the vehicle and he kept responding with a "NO". After numerous commands, I was able to get Sullivan inside the vehicle. I then transported Sullivan to the Boynton Beach Police Department to continue my investigation. I arrived at BBPD at 0256hrs, started my 20 minutes observation at 0300hrs and completed at 0320hrs. Upon completion I requested Sullivan to provide a sample of his breath to determine the alcohol content, which he refused. I therefore read Sullivan Implied Consent, which he advised that he did not understand. I then read Implied Consent two additional times, which Sullivan advised that he still didn't understand. I asked Sullivan, what part he didn't understand, which he stated "all of it". I then asked Sullivan if it would be easier if he read it, which he did not answer. Sullivan advised that he could not understand my speech and advised that I couldn't read. Therefore Officer Roedel assisted and read Implied Consent to Sullivan. When asked if he understood, Sullivan advised "NO". I asked Sullivan if he wanted me to read it again, which he "I'm not going to understand it". I advised Sullivan that I would read it one more time, and continue with the investigation. I then read Implied Consent to Sullivan and asked if he understood which he stated no. At that point, due to Sullivan being uncooperative and refusing to understand what is being read, I continued the investigation. I requested a second time for Sullivan to provide a sample of his breath, which he advised that he did not understand anything I was talking about. Sullivan was very argumentative. I attempted to explain to Sullivan what I was requesting, which he stated he did not understand. I advised Sullivan that I was going to request one more time and continue with my investigation. I requested one more time for a sample of Sullivan breath, which he stated that he did not understand. Therefore I understood Sullivan behavior as being uncooperative and on purpose, therefore the request for the breath sample was a refusal. I then began to read Sullivan his Miranda Warnings, which Sullivan advised that he wish to remain silent. I asked Sullivan if he understood, which he stated no. I then asked Sullivan if he wanted me to repeat to warnings, which he refused to answer. I asked Sullivan if he wanted to answer the questions on the packet, which he refused to answer.

Based on the above stated facts I have established Probable Cause to charge Sullivan with 1M count of DUI pursuant with F.S.S. 316.193.1. Sullivan was later TOT PBCJ. BAT Video was later placed into BBPD Evidence, Sullivan's vehicle was left on scene on his request.

Sullivan was given a citation by Officer Grigorian for his initial speed, 60 mph in a 40 mph zone and failure to maintain a single lane.


\*\*\*\*\*SUPPLEMENTAL PROBABLE CAUSE\*\*\*\*\*

On Sunday, September 25, 2016 at approximately 0226 hours I was on patrol in the area of 1500 West State Road 804 (West Boynton Beach Boulevard) in my fully marked BBPD patrol vehicle #4451.



While on patrol I observed a white 2004 Chevrolet Tahoe bearing FL Tag #CHBT99 traveling eastbound on West State Road 804 in the center lane at approximately 65 M.P.H. I paced the above listed vehicle for approximately 3/4 mile and determined that the vehicle was traveling 60 M.P.H. It should be noted that while pacing the above listed vehicle I observed the vehicle failing to maintain a single lane (swaying in the lane).

I then conducted a traffic stop on the above listed vehicle in the parking lot of 744 West Boynton Beach Boulevard (7-11) for the above listed traffic offenses. Contact was then made with driver w/m Sean Sullivan and front seat passenger h/m Carlos Vilchez. It should be noted that while speaking with Sullivan I could detect a strong odor of alcohol emanating from his breath, blood shot eyes and slurred speech. Based on the above I requested DUI Officer Castro respond to the scene to conduct a DUI investigation.

I had no further involvement in this case.
