A bystander Jason Budd stated at approximately 6649 N Federal Hwy he observed a white male, later identified as Sean Wright, grab a female, later identified as Silvia Wright, and push her into the car. The vehicle was described as a black Toyota Corolla with Florida License Plate ECVF83. Budd continued to follow the vehicle until Sgt. Adams of the Boca Raton Police Department was able to pull the vehicle over at 200 W Palmetto. See Sgt. Adams supplement for further. Budd completed a Sworn Written Statement which was entered into BRPD evidence.</p> <p>Sean and Silvia were separated and questioned regarding the aforementioned allegations. It was determined that the crime of domestic battery did not occur. Silvia stated she was heavily intoxicated and was vomiting outside the vehicle at one point but couldn't recall where. Silvia stated she might have been escorted back to the vehicle by her husband and he could have placed his hands on her then, but she could not remember. Sean's story was constantly changing, he kept getting confused on where he came from and the direction he travelled to get to 200 W Palmetto. Sean stated the party was in Delray then moments later stated it was in Boca Raton at Platforms. Furthermore, he claimed they did not stop anywhere after leaving Platforms, and then he stated they stopped at a gas station. Sean stated Silvia did throw up at one point possibly. Sean stated he did not put his hands on his wife at all. There were no visible marks on either party to indicate anything physical occurred. Sean and Silvia both stated they had been drinking at a holiday work party.</p> <p>While conducting my domestic battery investigation, I observed signs of impairment; the pungent odor of an alcoholic beverage emanating from Sean's person, and his eyes were</p>

<p>glassy and red. At one point during the aforementioned investigation Sean stated he had too much to drink and he shouldn't have been driving. I explained my observations to Sean and asked if he would attempt the field sobriety exercises to dispel my concern that he was operating a vehicle impaired. Sean agreed to attempt the exercise. I then asked Sean to stand up and walk to the designated area to perform the exercises.</p> <p>As Sean spoke, I could smell the odor of an alcoholic beverage emanating from his person. Sean's eyes were glossy and red and he displayed slowed reactions when moving. I asked Sean to perform Standardized Field Sobriety Tasks (SFSTs) and he willingly participated. He then stepped to the designated area to begin the tasks. The ground was flat and level, and there was a straight painted white line that we could use for a walk and turn.</p> <p>The first task was the Horizontal Gaze Nystagmus. I observed Sean's eyes to be bloodshot and glassy. I observed his pupils to be of equal size and have equal tracking of the stimulus. I observed a lack of smooth pursuit in both eyes and in both directions. I observed the onset of nystagmus to be prior to 45 degrees in both eyes and in both directions. I observed a distinct and sustained nystagmus at maximum deviation in both eyes and in both directions.</p> <p>The second task was the Walk and Turn. Once we established the starting point for the Walk and Turn, I asked Sean if he had any problems which would prevent him from conducting the field sobriety tasks. Sean stated he didn't. After I gave the instructions to Sean at the task at hand, I asked if he understood. He advised he understood and was unable to maintain the starting position during the instructional phase. During the task he stepped off the line multiple times (steps 4, 6, 7 and 8). During the task he almost fell over at one point losing his balance. He was unable to keep all his steps heel to toe. Finally at the conclusion of the task he stated I guess I can't do it.</p> <p>The third task was the one leg stand. I gave the instructions and demonstrated the task. I asked Sean if he had any questions and he advised he did not. Sean was unable to keep his arms at his side, and swayed on occasion. During the exercise he used his arms to maintain balance. He also fell multiple times specifically at one thousand three and one thousand six.</p> <p>The fourth task was the English Alphabet from A to Z in a non-rhythmic manner. During the demonstration he skipped multiple letters. Furthermore, his hands were not at his side and he indicated he understood what non-rhythmic manner is, but persisted to state the alphabet rhythmically.</p> <p>The fifth task was the finger to nose task. I gave Sean the instructions and demonstrated the task at hand. During the task he missed his nose on three occasions,</p>

and kept his eyes open, contrary to my instructions.

At 0122 hours, based on my observations, I placed Sean under arrest for DUI. I then transported Sean to Boca Raton Police holding facility for processing. Officer Reissi was inside the holding facility to operate Intoxilyzer 8000 testing. Sean refused to provide a breath sample.

Sean was charged pursuant to F.S.S. 316.193(1) DUI on December 11, 2016, in Palm County Florida. The video of the incident was later submitted into BRPD evidence. Sean was given the court date of January 09, 2016 at 8:30 AM at 200 West Atlantic Avenue Delray Beach Fl. Sean was issued a citation for driving under the influence pursuant to F.S.S 316.193(1).

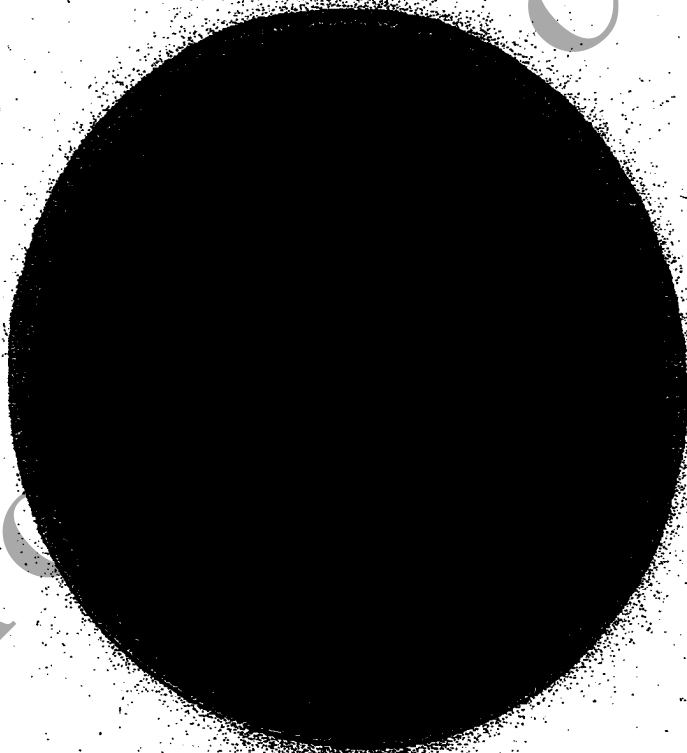
