The complainant, Break Yard restaurant bar and Grill manager, Joseph Osie indicated that a patron, later identified as Sebastien Dupont, came to the bar at the aforementioned incident address and appeared to be under the influence of alcoholic beverages. He added that Sebastien proceeded to buy his first drink and immediately smashed it on the floor inside the restaurant. In addition, he said, Sebastien began to scream and yell profanities at other restaurant's attendees causing a disturbance. When he asked Sebastien to leave the premises, he explained, Sebastien turned toward him and threatened to engage in a physical fight with him and other guests. Moreover, Joseph, said, Sebastien then went outside and started running in front moving vehicles. Joseph nevertheless concluded that he asked Sebastien to leave the premises in several occasions, but he had refused to do so. He provided a sworn written statement attesting to the above facts.</p> <p>Upon my arrival, I found Sebastien along with Joseph in front of the restaurant at the aforementioned incident address. I noticed that he was screaming an yelling at the restaurant's manager and other patrons telling them he wanted to kick their "ass". The complainant, Joseph, furthermore asked him several times in front me to leave the promises. However, he refused to do so even after I asked him to leave. Based on the above facts, I placed him under arrest for trespassing after warnings pursuant to FSS 810.08(1).</p>
