## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 07/16/2017 at approximately 0058 hours I responded to the intersection of Boca Chase Drive and State Road 7, in unincorporated Palm Beach County, in reference to a DUI crash investigation. Prior to my arrival Deputy J. Rivera ID: 13918 was providing backup to another Deputy in the 17100 block of State Road 7 on an unrelated DUI investigation. While stopped on the north side of State Road 7 with his lights activated a silver Honda Civic bearing Florida tag CWX562 sideswiped his marked PBS patrol vehicle along the driver's side of the vehicle. Deputy Rivera was able to follow the vehicle and effected a traffic stop at the intersection of State Road 7 and Clint Moore Road. Deputy Rivera detained the driver of the Honda, who was later identified as Seiichiro Kashiwagi, through his Florida issued driver's license. Seiichiro was also the registered owner of the Honda. Upon my arrival I observed Deputy Rivera's patrol vehicle. It had obvious driver's side damage done to the driver's front door and front quarter panel. Stopped in front of D/S River's patrol vehicle in the through lane closest to the north side of the roadway was the Honda Civic. At that time Seiichiro was handcuffed in the rear of Deputy Rivera's patrol vehicle in reference to the leaving the scene of a crash with damage.

## OBSERVATION OF DRIVER:

I then proceeded to observe the Honda. The passenger side of the vehicle had noticeable white transfer paint and scratches consistent with impacting the patrol vehicle. I retrieved Seiichiro's Florida driver's license from the front passenger seat of the Honda. I also observed two small open bottles of Sutter Home wine along with two other closed bottles. The open bottles had appeared to be consumed with only a small remaining amount of liquid inside. Deputy Di Orsini ID: 12462 conducted the crash investigation (crash case 17103081). I then spoke with Deputy Rivera who stated that Seiichiro's eyes were red and bloodshot. Seiichiro smelled like grease according to Deputy Rivera as if Seiichiro worked in the food business. Seiichiro appeared slow according to Deputy Rivera as well. Deputy Rivera asked Seiichiro if he was hurt to which he stated no. Deputy Rivera stated that Seiichiro did not even try to stop post crash. Deputy Rivera filled out a supplemental probable cause affidavit (see attached for further). Palm Beach County Fire Rescue already responded to the scene to medically assess Seiichiro who was not transported to the hospital with any injuries (run number 17076486)

## DRIVER'S STATEMENTS:

I then made contact with Seiichiro and escorted him out of the patrol vehicle. Since Seiichiro already attempted to flee the scene of a crash I decided to keep him in handcuffs for the time being. As I assisted him from the patrol vehicle I could smell the obvious odor of an unknown alcoholic beverage on his breath as he spoke. I could also smell a slight grease smell as if he worked in the food industry. He was wearing a green chef's jacket, black pants, and black shoes with glasses. Seiichiro appeared dazed and lethargic. His face appeared droopy, red, and flushed. He had a slight circular sway as he stood still. His eyes were very red, glassy, and bloodshot (see attached PC page for further).

## ODORS:

The obvious odor of an unknown alcoholic beverage on his breath as he spoke. Slight grease smell.

## GENERAL OBSERVATIONS

SPEECH: Slurred, mumbled, unclear, accent

ATTITUDE: Calm, compliant, lethargic, slowed, dazed look

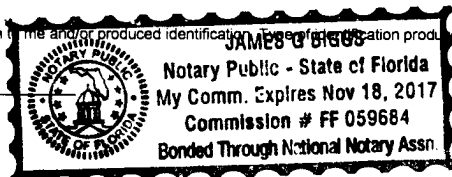

**Other Observations:**

Seiichiro's eyes tracked equally, the pupils were the same size and were appropriate for the lighting conditions, and no resting nystagmus was observed. Vertical gaze nystagmus was administered and was observed. Lack of convergence was administered and was observed. eyes stayed straight ahead and did not converge. He also closed his eyes instead of keeping focus on the stimulus during LOC. Seiichiro moved his head during the task, swayed in a circular motion, and moved feet apart from instructed position.

**WALK & TURN:**

Prior to the task I removed Seiichiro's handcuffs, confirmed he wanted to submit to the SFSTs which he did and had him place his glasses back on. I had Seiichiro assist in placing a tape line on the road way for the tasks which he did. In doing so I observed that he began walking toward me instead of placing it on the ground. He also stood on the tape with both feet and not his left foot as instructed. Seiichiro stated he was okay to walk in his shoes. I explained and demonstrated the instructions for the walk and turn task to Seiichiro who stated that he understood. During the task I observed that Seiichiro had the following cues: couldn't keep balance while listening to instructions (moved feet from line and arms from side); missed heel-to-toe on steps: 2 - 8 on first set then on all on return; stepped off the line on step 6 on return set; used arms for balance (raises arms over six inches); improper turn (turned without keeping front foot on ground, lifted both feet from ground); took incorrect number of steps: 8 on first set; did not count as instructed; swayed in instructed position.

**ONE LEG STAND:**

I explained and demonstrated the instructions for the one leg stand task to Seiichiro who stated that he understood. During the task I observed that Seiichiro had the following cues: swayed while balancing; used arms for balance (raises arms over six inches); hopped while balancing; put right foot down 3 times before switching to left and placing it down once (before 30 seconds); did not count as instructed; swayed in a circular motion during instructions.

**FINGER TO NOSE:**

I explained and demonstrated the instructions for the finger to nose task to Seiichiro. I explained what is considered the tip of the finger and tip of the nose to Seiichiro who stated that he understood. He also knew his left from his right. During the task I observed that Seiichiro had the following cues: upon bringing left hand to nose on first instructed hand Seiichiro lost balance and stumbled forward; he stumbled to his left again prior to resuming the task; task was restarted and Seiichiro opened eyes, tilted head forward, and swayed back to front; upon placing his right hand on his nose he again stumbled forward almost falling. The remainder of the task was not conducted due to safety concerns.

**ROMBERG ALPHABET:**

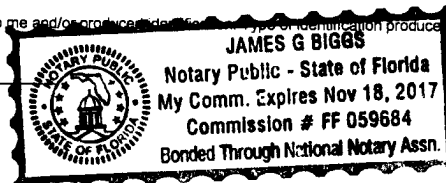
