<p>ON 1/26/17 AT APPROXIMATELY 2246 HOURS, I WAS CONDUCTING RADAR ENFORCEMENT ON S JOG ROAD, NORTH OF LANTANA RD. WHILE I WAS PARKED IN THE MEDIAN FACING NORTHBOUND ON S JOG ROAD, I OBSERVED A VEHICLE HEADED TOWARD ME, AT A HIGHER RATE OF SPEED THAN NORMAL FOR THE AREA. I ESTIMATED THAT THE VEHICLE WAS TRAVELING AT 58 MPH IN A POSTED 45 MPH ZONE. AS I LOOKED AT MY IN VEHICLE RADAR UNIT, AND OBSERVED THE DOPPLER TONE INDICATED A READING OF 59 MPH IN A POSTED 45 MPH ZONE.</p> <p>AS I APPROACHED THE VEHICLE, I OBSERVED THAT IT WAS A GRAY HYUNDAI SUV, AND HAD AN ATTACHED FLORIDA TAG OF 137QNF. AS I GOT BEHIND THE VEHICLE, I BEGAN TO CONDUCT A TRAFFIC STOP, I ACTIVATED MY OVERHEAD LIGHTS AND SIREN, AND NOTIFIED DISPATCH THAT I WAS GOING TO CONDUCT A TRAFFIC STOP ON THE VEHICLE. THE VEHICLE FIRST PULLED OVER, AND ACTIVATED ITS HAZARD LIGHTS. IT THEN SLOWED TO A STOP. AS I BEGAN TO EXIT MY VEHICLE THE VEHICLE CONTINUED TO MOVE. I AGAIN ACTIVATED MY SIREN, AND GOT ON MY P.A. SYSTEM TELLING THE DRIVER TO STOP THE VEHICLE.</p> <p>AS I EXITED MY PATROL VEHICLE, INV. L. CHIQUITO-RODRIGUEZ #18334 AND I APPROACHED THE VEHICLE. AS I APPROACHED THE DRIVER SIDE OF THE VEHICLE, I OBSERVED THAT IT WAS OCCUPIED BY A WHITE FEMALE, AND A BLACK MALE IN THE PASSENGER SEAT. THE PASSENGER DID NOT HAVE ON A SEATBELT. THE DRIVER, WHO WAS LATER IDENTIFIED AS SELENA ELYSE CELICH, BY HER FLORIDA DRIVER'S LICENSE, WAS OBSERVED TO HAVE RED EYES, AND LOOKED AT ME WITH A SCARED LOOK. I ASKED SELENA FOR HER DRIVERS LICENSE, REGISTRATION, AND PROOF OF INSURANCE. AS I SPOKE TO SELENA I OBSERVED THAT THERE WAS THE OBVIOUS ODOR OF MARIJUANA COMING FROM THE VEHICLE. I ALSO ASKED THE PASSENGER FOR HIS ID/DL. I WAS LATER HANDED THE DL BELONGING TO JALIL ZAKI TALLEY. AS INV. CHIQUITO-RODRIGUEZ WAS ON THE SIDE OF JALIL, SHE OBSERVED HIM REACH INTO THE PASSENGER DOOR POCKET. SHE INFORMED HIM NOT TO DO THAT AGAIN. SHE THEN OBSERVED HIM NOT OBEY HER COMMAND, AND AGAIN WAS REACHING HIS HAND DOWNWARD IN THAT AREA.</p> <p>DUE TO THE ODOR COMING FROM THE VEHICLE, I ASKED THE OCCUPANTS IF THERE WAS ANY ADDITIONAL MARIJUANA IN THE VEHICLE, AS IF WAS UNDER A CERTAIN AMOUNT, I WOULD RELEASE THAT PERSON WITH A COURT DATE / NOTICE TO APPEAR. I WAS INFORMED THAT SELENA HAD SMOKED ABOUT AN HOUR AGO, AND THAT THERE WAS NOTHING LEFT IN THE VEHICLE. AT THAT TIME INV. CHIQUITO-RODRIGUEZ LOCATED A SMALL CLEAR AND RED BAG THAT CONTAINED SUSPECTED MARIJUANA, FROM THE DRIVER DOOR POCKET.</p> <p>INV. CHIQUITO-RODRIGUEZ AND I THEN CHANGED PLACES DUE TO THE MALE/FEMALE D/S. I THEN HAD JALIL EXIT THE VEHICLE, AND I PLACED HIM INTO HANDCUFFS THAT WERE DOUBLE LOCKED AND CHECKED FOR PROPER FITTING. AS JALIL WAS EXITING THE VEHICLE, I OBSERVED SELENA WITH HER HANDS NEAR THE OPEN CENTER CONSOLE, UNDER THE ASHTRAY. I INFORMED HER TO PUT HER HANDS BACK, AS I BROUGHT JALIL OUT OF THE VEHICLE, HE CONTINUALLY WAS REACHING TOWARD HIS REAR WAISTBAND. HE STATED THAT HE DID NOT WANT HIS PANTS TO FALL. AS I WALKED HIM, HOLDING HIS PANTS UP, TO THE FRONT OF MY CAR, I BEGAN TO SEARCH HIM. AS I SEARCHED HIM, I LOCATED A PACKAGE CONTAINING DUTCH CIGARILLOS IN THIS PACKAGE, TO THE AREA THAT HE WAS REACHING TOWARD, I OBSERVED THAT THERE WAS A SMALL PIECE OF SUSPECTED MARIJUANA. HE WAS THEN PLACED INTO THE BACK OF MY PATROL VEHICLE.</p> <p>AS I BEGAN TO GO BACK TO THE VEHICLE, I WAS INFORMED BY SELENA THAT SOMEONE MAY HAVE LEFT SOMETHING IN HER CAR, AND THAT SHE WAS TRYING TO GET RID OF IT. IT SHOULD BE NOTED THAT IT IS POSSIBLE THAT SELENA PLACED THIS ITEM THERE AS INV. CHIQUITO-RODRIGUEZ AND I WERE CHANGING PLACES, AND PAYING MORE ATTENTION TO JALIL. IT SHOULD ALSO BE NOTED THAT AT NO TIME BEFORE THIS DID EITHER JALIL OR SELENA INFORM ME OF THIS.</p> <p>I THEN WENT TO THE AREA THAT SELENA WAS REACHING, AND OBSERVED A VERY SMALL PLASTIC BAGGIE, THE SIZE THAT WILL NOT FIT EVEN A NICKEL INTO, IN THE CENTER CONSOLE UNDER A SMALL PLACE PIECE OF PLASTIC. I OBSERVED THAT IT CONTAINED PINK CRYSTALS. I THEN INFORMED INV. CHIQUITO-RODRIGUEZ TO PLACE SELENA INTO HANDCUFFS AND TO PLACE HER INTO THE CAR, AS THIS WAS NOT JUST MARIJUANA, IT WAS ANOTHER TYPE OF DRUG.</p> <p>CONTACT WAS MADE WITH A NARCOTICS AGENT, AS TO THE PROBABILITY OF DRUG TYPE, AND I WAS INFORMED TO TEST IT FOR METHAMPHETAMINE. I USED A LIBERMANN REAGENT TEST KIT, AND IT YIELDED POSITIVE, AND TURNED ORANGE / PEACH.</p> <p>INV. CHIQUITO-RODRIGUEZ REQUESTED A ROTATION TOW OF THE VEHICLE, AND D&D'S AUTOMOTIVE RESPONDED.</p> <p>BASED ON MY INVESTIGATION I FIND THAT PROBABLE CAUSE EXISTS TO CHARGE SELENA ELYSE CELICH IN VIOLATION OF FSS. 893.13(6A), POSSESSION OF METHAMPHETAMINE. JALIL WAS ALSO ARRESTED FOR POSSESSION OF MARIJUANA.</p>
