ON THE ABOVE DATE AND TIME I RESPONDED TO LION COUNTRY SAFARI LOCATED AT 2003 LION COUNTRY SAFARI RD, LOXAHATCHEE, IN REFERENCE TO A BLACK MERCEDES DRIVING ERRATIC IN THE PARK. LION COUNTRY SAFARI IS A DRIVE THROUGH ZOO TYPE PARK WHERE THE ZOO ANIMALS CAN COME UP TO YOUR CAR. THE OCCUPANTS OF THE VEHICLE HAD OPEN CONTAINERS OF ALCOHOL AND WERE GETTING OUT OF THE VEHICLE AROUND THE ANIMALS.

UPON ARRIVAL I MET WITH BRIAN DOWLING, THE PARK MANAGER. HE POINTED OUT THE VEHICLE DRIVING ON A ROADWAY INSIDE THE PARKING LOT AREA. THE SUBJECT THAT WAS DRIVING THE BLACK MERCEDES BEARING FL TAG BXQN64 STOPPED DRIVING, BACKED UP BEHIND THE STOP SIGN, STOPPED THEN PUT HIS VEHICLE IN PARK. I THEN MADE CONTACT WITH THE DRIVER LATER IDENTIFIED AS SEMYON ZHUKOVSKIY. THE PASSENGER COMPARTMENT HAD A STRONG ODOR OF ALCOHOL. AS SEMYON TALKED I COULD SMELL ALCOHOL ON HIS BREATH. HIS EYES WERE GLOSSY AND HE WAS SLURRING HIS WORDS. HE TOLD ME THAT HE SPEAKS RUSSIAN BUT KNOWS ENGLISH VERY WELL AND DENIED NEEDING A TRANSLATOR. HE COULD NOT TELL ME WHERE HIS CAR KEYS WERE OR WHERE HIS DRIVERS LICENSE WAS. IT APPEARED AS IF HE HAD URINATED IN HIS PANTS. IN THE BACK SEAT OF THE CAR THERE WERE SEVERAL EMPTY BEER BOTTLES AND A OPEN BOTTLE OF MAKERS MARK WHISKEY.

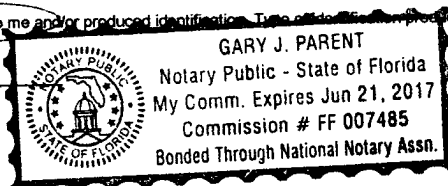

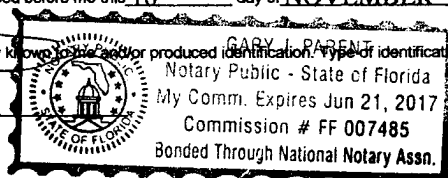
