<p>On Friday 06/30/2017 at approximately 1808 hours, I was while patrolling the Boca Regional Park at 11435 Park Access Road in unincorporated Boca Raton, in Palm Beach County Florida, 33498 in my marked patrol car. I saw a white Honda Civic (bearing FL tag 6460FC) with four people inside of it immediately get out of the car and walk into another car upon seeing me. As I drove to the front of the cars I could smell the odor of marijuana coming from the direction of the white car.</p> <p>I then turned my car around and parked behind the two cars, leaving them ample space to leave, never turning on my red and blue overhead lights or giving them any orders to stop. I exited my car and asked the two occupants of the Honda how they were doing. Upon walking up to the front passenger side door I could smell the odor of raw marijuana coming from inside of the car. In the front passenger seat of the Civic was a white female later identified as Serena Gibbs, and a white male in the driver seat identified as Phillip Ruffolo. I had both Phillip and Serena step out of the car. As Philip stepped out of the car I could see small flakes of a green leafy like substance on his shirt that I know to be marijuana from my training and experience as a law enforcement officer. While searching under the front passenger seat where Serena was sitting I found a purse stuffed under the seat.</p> <p>Upon opening the bag I found two clear bags with a green leafy like substance, a metal grinder used to grind marijuana with a green leafy like substance inside, a blue container with more green leafy like substance inside, a small glass jar with a green leafy like substance inside, a glass pipe with burnt marijuana residue inside, and a scale with green leafy like substance on it. I then used a Duquenois Reagent #8 test kit to field test the marijuana, which tested positive for THC. I later packaged all of the green leafy like substance together which had a total package weight of 26 grams. I also tested a vape pen that was found in the same purse that had a brown liquid inside with a Duquenois reagent #8 test kit, which tested positive for THC. The total package weight of the hash oil is 1 gram.</p> <p>Serena was read her Miranda rights from a preprinted PBSO Miranda warnings card to which she stated that she understood her rights. When asked about the bag with the marijuana and other drug paraphernalia, she stated they were hers. Based on my above investigation, Serena Gibbs is being charged with possession of marijuana more than 20 grams pursuant to fss 893.13(6)(A), possession of hash oil pursuant to fss 893.13(6)(A), and four counts of drug paraphernalia pursuant to fss 893.147(A).</p>
