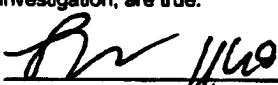

	times in the face with a closed fist while in the garage of their residence, 367 E Mallory Cir. Wright stated that they had begun fighting because Klein was accusing her of lying which started on the car ride home. Klein stated that they had just returned home and Wright would not give him his phone and instead threw it on the passenger side of their black Mercedes sedan (FL Tag CKM01). Klein was seated in the driver seat and Wright was seated in the front passenger seat. As Klein reached over to grab his phone he stated that a fight occurred between him and Wright but was unwilling to state who started it. I observed discoloration underneath and on Wright's right eye which corroborated her story. I did not observe any marks or discoloration on Klein's person. Crime Scene responded and photographed Wright's injuries. Klein and Wright have been living together as a family for nearly 3 years and are currently engaged. Due to the above stated facts, there is probable cause to charge Klein with Simple Battery (Domestic) per F.S.S. 784.03(1A1).

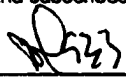
