 On the 10 day of AUGUST 2019 at 0051 A.M. P.M. (Specifically include facts constituting cause for arrest.)

On Saturday, August 10,, 2019 at approximately 0051 hours, while patrolling northbound on North Military Trail, West Palm Beach (Palm Beach County) Florida, I stopped a white Mercedes Benz, bearing current Massachusetts license plates "EMS 3", for traveling 66 miles per hour(mph) in a posted 45mph speed zone. My rear antenna was set to the "Same Direction" mode as I was in the middle lane. I heard a loud steady high pitch sounding from my Radar's Audio Doppler displaying a speed of 66 mph inside the target window. I looked in my rear view mirror and saw a white vehicle closing rapidly and switching to the outside lane. The speed of the vehicle matched the tone of the Doppler and the speed inside the target window. The vehicle overtook me and the high pitch from the Doppler ceased in sounding as the target speed vanished from the screen. I activated my emergency lights in an effort to stop the vehicle for speeding. The vehicle stopped in the roadway at the intersection of Community Driver and N Military Trail. Over my PA radio system I asked the driver to pull into the parking lot so we would not be on the roadway. The vehicle pulled into the parking lot. I approached the vehicle from the driver side and made contact with a white male driver who was the sole occupant inside it. He was later identified as Seth Christopher Lovely by his Florida driver license. I eventually told him he was being stopped for traveling 66mph in a posted 45mph speed zone. During my interview I noticed his eyes were red, watery and glossy. His cheeks were flushed, his mouth was dry and he slurred his speech while speaking. His movements were slow, calculated and lethargic. He was wearing short khaki pants, a gray shirt with blue short sleeves and white sneakers. I could smell a strong odor of an unknown alcoholic beverage emanating from the inside of the vehicle. I told the driver I had a suspicion that he had been drinking an unspecified amount of alcoholic beverages. He told me he was not drinking and he was returning home from Taco Bells. I later noticed he had a wrist band on his arm that signified he may have been at a club. I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. He consented to performing the SFSTs. I asked him to exit the vehicle. He lost his balance and was unstable on his feet while standing. Prior to his performance I asked if he had any physical problems with his body that would inhibit him from performing light physical movements. The defendant told me he was fine and did not have any medical problems. During the tasks however, he complained of a problem with his left knee. He told me he does cross fit and injured his knee.

 On the 10 day of AUGUST 2019 at 0051 A.M. P.M. (Specifically include facts constituting cause for arrest.)

I placed a yellow strip of tape on the pavement that formed a line. He acknowledged the tape by placing his left foot on it when prompt to do so. The area consisted of a smooth and level surface that was free from obstructions and debris. It was well lighted by the lights from my patrol car and street lighting. I could now smell a strong odor of an unknown alcoholic beverage coming from his breath that intensified when he spoke. The following SFSTs were explained, demonstrated and acknowledged by him prior to his performance: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Alphabet Recitation. His deficiencies were recorded on another form on this worksheet. At the conclusion of the SFSTs, coupled with my observation of the defendant's vehicle in motion and my observation of personal indicators of impairment exhibited by the defendant, probable cause was established for DUI. I told the defendant they were being placed under lawful arrest for DUI. The defendant was searched and handcuffed (double locked and checked for tightness) prior to being seated into the rear of my patrol car. Deputy Lisa Benson was on scene as a back up officer and arranged for the defendant's vehicle to be towed by a tow service from PBSO's rotation list. Babbco Towing Company responded and impounded the defendant's vehicle to their lot. Meanwhile I began transport to the main jail breath analysis facility for further processing. Upon our arrival I escorted the defendant into the facility and began a 20 minute observation period. During this time the defendant did not ingest anything into his body orally or otherwise. Neither did he regurgitate. I escorted him into the testing room and asked him to provide breath samples for the purpose of determining his alcohol content. He agreed to give the samples. The defendant gave two adequate breath samples that rendered results of .174 and .170. I advised him of his Constitutional Rights and asked if he understood his "rights". He told me he did understand his "rights". I asked if he would consent to an interview and he declined. The defendant was cited for speeding and booked into the main jail for DUI.

Subject swayed while performing this task. He turned his head while performing this task

WALK & TURN:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE WALK AND TURN. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject was unable to maintain his balance while placed in the instructional position. He swayed and ultimately abandoned the position. During the task the subject stepped off the line, did not touch heel to toe, stopped to steady himself, took an incorrect number of steps, he turned improperly and asked for additional instructions and did not keep his arms by his side

ONE LEG STAND:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE ONE LEG STAND. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject did not raise his leg 4 to 6 inches as instructed, he did not keep his arms by his side, he could not maintain his balance while his leg/foot was extended and he dropped his foot on the ground.

FINGER TO NOSE:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE FINGER TO NOSE. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed while performing this task, he failed to touch the tip of his finger to the tip of his nose on all six attempts, rather he touched the bridge, sides and underneath his nose. He failed to return his arms to his side after making contact with his facial area.

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE ROMBERG ALPHABET TASK. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. 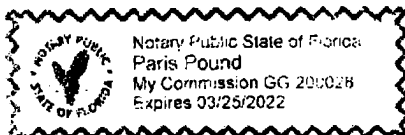
