## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time I responded to the area of Jog Rd and Atlantic Ave in unincorporated Delray Beach, FL, in reference to a vehicle crash, ref. PBSO case #16-130804. Upon my arrival I made contact with Seth D. Lieberman who was standing by the driver doorway of of his black in color Ram pickup bearing FL tag 885MUK. I advised Seth that I was going to investigate the vehicle crash and asked him what had occurred. Seth stated that he bumped the vehicle in front on him. The driver of the other vehicle involved, stated she observed Seth sitting in the driver seat behind the steering wheel upon exiting her vehicle. She later later provided a sworn written statement.

## OBSERVATION OF DRIVER:

While speaking with Seth I observed that his speech was slightly slurred and he had a strong odor of an unknown alcoholic beverage emitting from his person.

## DRIVER'S STATEMENTS:

I explained to Seth that I was finished with my vehicle crash investigation and was now going to conduct a DUI investigation. I asked Seth if he would perform some road side task to determine if he was driving while impaired. Seth stated that he would not perform anything. I further explained to Seth that if he did not perform the road side tasks I would have to base my investigation on what I had. Seth later agreed to perform the tasks.

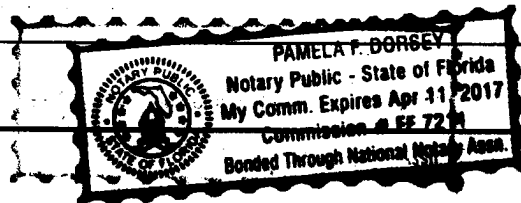

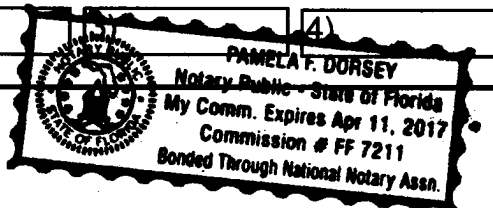

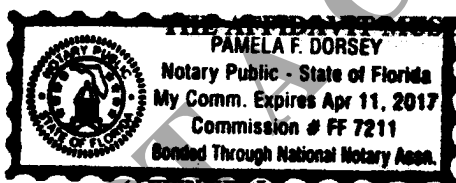
