Shane Appelbaum, choked and hit him.

Alan advised that he arrived to work this morning around 0830 hours, and while sitting in his car he was approached by his son, Shane, who was banging on the car window. Alan exited the vehicle to ask Shane what he wanted. According to Alan, the two have a tumultuous relationship and do not speak often. Alan advised that the last time he had any communication was approximately three weeks ago when they came in contact at the elevator of the building they both coincidentally work at. Alan explained that the relationship has been damaged ever since Alan and Shane's mother divorced 17 years ago. When Alan stepped out of the car, Shane started yelling at Alan repeating multiple times, "I'm going to fucking kill you. Don't ever speak about me again." While Shane was yelling at Alan, Shane used both of his hands to grab and squeeze Alan's neck. Alan advised that during the approximate 8 to 10 second strangulation period, his airway was restricted but he did not lose consciousness. Shane continued to yell at Alan stating, "I'm going to kill you". Alan attempted to calm Shane down, but was unable to do so. Shane released his hands from Alan's neck and then close fist punched him once in the stomach. Alan advised that Shane left in an unknown direction. Alan then called the police.

Boca Raton Fire Rescue Medic 6 responded to 2700 W Military Trl and transported Alan to Boca Raton Regional Hospital. I observed to a small laceration on Alan's brow at the top of his nose. I also observed bruising on his neck, in the shape of fingers, which was consistent with Alan's narration of the altercation.

I attempted to make contact with Shane at his workplace, but his co-workers advised that he had not come into the office yet. I then attempted to make contact via landline, but he did not answer. I received a phone call from Shane's lawyer, Michelle Merson, who advised they wished to meet at the police department after being advised of the allegations against Shane. At approximately 1400 hours, Shane Appelbaum along with his lawyer, Michelle Merson came to the Boca Raton Police Department to surrender. Merson explained that her client, Shane Appelbaum wished to invoke his Constitutional Rights and not speak with us about the allegations.

Based on my investigation, I found that Shane Appelbaum strangled the victim, impeded his normal breathing, and battered a person over the age of 65. Appelbaum was arrested for Felony Domestic Battery by Strangulation pursuant to F.S. 784.041(2A) and Battery on Persons 65 Years of Age or Older pursuant to F.S. 784.08(2C). Appelbaum was processed at BRPD booking facility and later transported to FBCJ.
