On 04-27-18 at approximately 09:35 hrs. I responded to 22 Westgate Way Lane in reference to a disturbance recall.

Upon arrival contact was made with caller Jonathan Margolies who advised while inside his residence his ex-girlfriend Shannon Ewing entered his residence without his permission and started a heated verbal dispute. Margolies advised that he asked Ewing to leave his residence multiple times but she refused.

Margolies advised that at no time did he invite or welcome Ewing into his residence. Margolies advised that Ewing has no clothes at his residence nor has she ever resided at his residence. Margolies advised that Ewing left the area upon noticing that BBPD was being called.



Margolies provided BBPD with a cell phone video of Ewing in front of his residence on the second floor arguing while stating "I don't care" prior to leaving.

Witness / Handyman James Rennie who was at Margolies home in reference to repairing a bedroom window that Ewing had broken an hour prior (BBPD Case# 18-022847) advised that while outside the residence repairing the window Ewing entered the home and began a heated argument with Margolies.

Rennie advised that he heard Margolies request Ewing to leave his residence multiple times but she did not comply. Rennie advised that Ewing later left and returned back while officers were arriving on scene. Rennie advised that at no time did he observe any physical confrontation between the two.

It should be noted reference to case# 18-022847 contact had been made with Ewing at her residence when she was advised per Margolies request that she was not welcome to his residence in an effort to avoid any further confrontation. Ewing acknowledged that she fully understood and would not return to Margolies home and would seek a court order restraining against him.

Upon making contact with Ewing in the parking lot in front of Margolies residence a strong odor of alcohol could be smelled emanating from her person. Upon questioning Ewing on why she was back at Margolies residence after being warned not to return she became argumentative prior to stating that she wanted to work things out with Margolies.
