NARRATIVE:

On 08/08/2019 at approximately 2125 hours D/S C. Cawthon #31829, D/S J. Espinosa #31295 and I, D/S Z. Hall #29819, were conducting proactive patrols in the area of Community Drive and N Military Trail, located in unincorporated West Palm Beach, Palm Beach County, FL 33417.

It should be noted, we were all wearing agency issued green tactical pants, black "SHERIFF" T-shirts, and a black tactical carrier which has patches on the front and rear that read "SHERIFF" in bold letters. Also affixed to the front of the vest is a 5 point star badge that clearly identifies us as law enforcement officers.

At or near the same time, I observed a white Lexus IS 300 traveling east on Community Drive, approaching N Military Trail. I examined the white Lexus and noticed that it did not have a tag properly attached to its rear. Due to the fact, I initiated a traffic stop on the white Lexus, which came to a final stop at 4604 Community Drive, West Palm Beach, FL 33417. It should be noted a records check was later conducted on the Vehicle Identification Number (VIN) which revealed that the white Lexus is assigned Florida License Plate "IC81PX".

I approached the driver side of the vehicle where I noticed that both, the driver, later identified as Jonathan Clements (DOB 11/28/1998), and the front passenger, later identified as Shannon Harold (DOB 08/27/1999) were reaching their arms towards the floor board of the vehicle. Before being able to speak to Mr. Clements, he spontaneously uttered "I know I am not supposed to be driving my license is no good, I

am just test driving my car". Additionally, as all of the windows were rolled down, I noticed the strong odor, which I know to be the scent of raw Marijuana, based off of my training, experience, and prior arrests emanating from the interior of the vehicle. Also worth noting, Ms. Harold spontaneously uttered "we just smoked Marijuana, but there should not be any in here". Due to the fact, both occupants were removed from the vehicle and placed into handcuffs, which were checked for proper fit and double locked.



Due to the odor of Marijuana, D/S L. Benson #16736 responded to the scene and conducted a search of Ms. Harold's person. Doing so revealed a prescription bottle, as well as a clear container, concealed inside of her shirt near her chest. A search of the mentioned prescription bottle revealed eight green pills which had "S902" imprinted on them. Utilizing "drugs.com" the mentioned pills were identified as Alprazolam, a Scheduled 4 Controlled Substance. The clear container held two white mushrooms, which I know to be a Psilocybin, based off of my training, experience, and prior arrests. It is worth noting that Ms. Harold spontaneously uttered "those are shrooms". I am aware that "shrooms" is a common street term when mentioning Psilocybin's.

A records check of Mr. Clements revealed that his license is suspended as of 08/07/2019 for Criminal Failure to Pay.

Based off of my aforementioned investigation, there is probable cause to arrest Jonathan Clements (DOB 11/28/1998), for Driving While License is Suspended (with knowledge)—FSS 322.34(2).

Shannon Harold (DOB 08/27/1999) is being arrested for Possession of Alprazolam—FSS 893.13(6a) and Possession of Psilocybin—FSS 893.13(6a), as she had these illegal substances in her possession.

It was determined through investigation that Clements is on probation reference to Felon in Possession of Firearm in Palm Beach County, which expires on 05-29-2023, case number 1811897. Due to Clements being arrested on this date for Driving with License Suspended with Knowledge pursuant to F.S.S. 322.34(2), Clements will be additionally charged with street probation violation as he has violated his probation with the new charge.
