D/S Schwartz (13670) responded to the scene and upon speaking with Jensen she told Schwartz that she had just left BB's and stated it was a Bar in east Boynton Beach.

A DUI unit was contacted and responded to the scene for further investigation. I wrote a citation (ABZT1ZE) to Jensen for running the red light. This concludes my involvement in this case.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I responded to assist DS Ramos #32395 with a possible impaired driver. Upon my arrival he advised me of the following: I observed a white Hyundai Sonata (FL Tag#DABX01) traveling westbound on W Boynton Beach Blvd in the far left left hand turn lane at the intersection of W Boynton Beach Blvd and S Military Trl. The traffic control device for a left hand turn was solid red. The above vehicle proceeded to make a u-turn at the intersection, running the red light. The vehicle then proceeded to travel eastbound on W Boynton Beach Blvd and proceeded to make a southbound turn into the Apple gate plaza which is located in the southeast corner of the above intersection. I activated my emergency equipment and the vehicle came to a complete stop in the parking lot of the plaza. I made a passenger side approach to the vehicle where I then made contact with the driver and only occupant Shannon Jensen who was identified by her Florida Drivers License. Upon speaking with Shannon I could smell the odor of an unknown alcoholic substance emanating from her breath. I also noticed that Jensen lit a cigarette. In speaking with Jensen I observed that she had a thick slurred speech and had trouble maintaining conversation with me. I also observed her eyes to be bloodshot and watery. D/S Schwartz (13670) responded to the scene and upon speaking with Jensen she told Schwartz that she had just left BB's and stated it was a Bar in east Boynton Beach.

OBSERVATION OF DRIVER:

Upon my arrival the driver was sitting in the driver's seat of her vehicle. I spoke with her and observed her eyes to be red and glassy. As she spoke, I could smell an obvious odor of an unknown alcoholic beverage on her breath. The driver's speech was slow and slurred. The driver was swaying as she stood and spoke with me.

Post-arrest, a open Amstel Light Beer bottle was located in the driver's purse, which was on the front passenger seat. This beer was freshly open and very cold to the touch.

DRIVER'S STATEMENTS:

The driver stated she was coming from her friend's house where she drank one beer and one shot of Tequilla.

ODORS:

As she spoke, I could smell an obvious odor of an unknown alcoholic beverage on her breath.

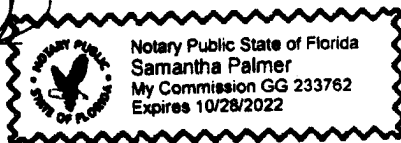

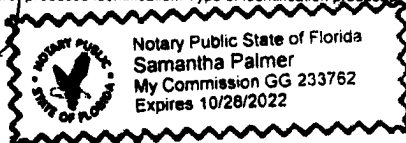
