On the **29th** day of **DECEMBER** 20**17** at **12:50** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On the above date and time, I was driving west on 68th Terrace in Jupiter, FL when I noticed a vehicle at a high rate of speed driving west on Booker T Blvd turning right onto 68th Terrace coming towards me. The vehicle made such an erratic turn that it went into the opposite lanes of travel and then nearly struck a curb as it over corrected.

I turned around and followed the vehicle north onto Island Way where it turned into the shopping plaza on the southeast corner of Island Way and Indiantown Road. There is a stop sign with a painted white stop bar near the entrance which the vehicle failed to stop at. The vehicle then parked in front of the Duffy's Restaurant and Park Ave BBQ restaurant which were both closed.


Due to the erratic driving I observed, I believed the vehicle may have had equipment malfunctions, or the driver was having a medical episode, or that the driver was impaired. Due to these observations as well as the stop sign violation (FSS 316.123(2A)), I conducted a traffic stop on the vehicle and made contact with the driver who was identified by her Florida license as Shannon Robinson.

Robinson admitted to making an erratic turn on 68th Terrace and admitted to running the stop sign within the plaza. She stated that she has been having issues with her boyfriend and family and was upset. While speaking with her, I noticed her eyes were red and glossy, her speech was slurred, and she smelled of alcohol. She initially denied drinking this evening but then admitted that she had been previously drinking. She then began sobbing uncontrollably and repeated the fact that she was having relationship/family issues several times.

D/S Booras 27529 arrived on scene and conducted a DUI investigation where Robinson was subsequently arrested.





(Specifically include facts constituting cause for arrest.)</p> <p>Upon completion of my D.U.I investigation, I informed Robinson that she was being arrested for D.U.I. and instructed her to place her hands behind her back. Robinson complied, and became hysterical crying, and begging to be driven home. Robinson's cuffs were stacked, double locked, and checked for proper fit, and she was placed into the back of my patrol vehicle, where I then applied her seat belt. While preparing to transport Robinson to the Palm Beach County BAT facility, she became increasingly aggressive and hostile in the back of my patrol vehicle, and began screaming and banging her head on the glass of my vehicle. Robinson made multiple statements begging for me to shoot her, and that she wanted to kill herself. While in the back of my patrol vehicle Robinson then slipped her cuffs to the front of her body, and then slipped them off completely. Robinson continued to bang her head and fists on the glass in my vehicle, and I called for more units to assist in attempting to control Robinson. Robinson continued to make more threats of suicide in the back of my patrol vehicle. My entire encounter with Robinson was captured on my in car camera system. Once more units arrived on scene, Robinson was removed from the back of my patrol vehicle, cuffed again, and hobbled. While attempting to cuff Robinson, she pulled her arm away, and attempted to put it to the front of her body. While attempting to put Robinson back into the back seat of my patrol vehicle, she refused to get in, and attempted to push her weight out. Robinson had to be forced into the vehicle, and was forced to lie down in the back seat. While pushing Robinson into the vehicle, she kicked out with her feet together at me, and attempted to kick me. At this time, Robinson began resisting with violence. While in the back of my patrol vehicle, Robinson made the following statement while being recorded on camera, "This is not a bribe, but I would pay you any amount of money to just take me home." I responded by informing Robinson that I was a law enforcement officer and would not be taking any bribes. Robinson was treated as a combative prisoner, and transported directly to the Palm Beach County Jail. Robinson was not able to be brought into the BAT, as she was suicidal, violent, aggressive, hostile, and a danger to herself. Robinson was given a refusal, as she did not provide a breath sample. Robinson was turned over to the Palm Beach County Jail staff as a combative prisoner, and was turned over to jail staff from the back seat of my vehicle. This case is cleared by arrest.</p>

OBSERVATION OF DRIVER:

On the above date and time, I responded to the area of Island Way and Indiantown Rd., in the city of Jupiter, in reference to providing routine back up for D/S Hole's traffic stop. Upon completion of the traffic stop, I conducted a criminal D.U.I investigation with the driver of the vehicle. The vehicle was a Silver Honda Accord with Florida License plate 5360XR, and the driver was later identified as Shannon Robinson W/F 2/18/96. Upon completion of my investigation, I found probable cause to arrest Robinson for D.U.I. Once Robinson was placed into handcuffs and placed into the back of my patrol vehicle, I later found Probable Cause to charge her with Resisting with Violence, and Bribery of a Public Servant.

Upon making contact with Robinson, behind the wheel of her vehicle, I asked her what she had to drink, and she informed me that she had two to three cups of white wine. She stated that she drank the wine from a, "Red Solo," cup, and that the cups were almost full. Robinson stated that she had her last drink, approximately two hours prior to my investigation, and has had some pasta and salad since. Robinson informed me that she has a lisp, and I was able to observe an issue with her speech that did not appear to be directly related to being impaired.

DRIVER'S STATEMENTS:

While speaking with Robinson at her vehicle, I could smell the strong odor of an unknown alcoholic beverage coming from her breath, which intensified as she spoke. Robinson's eyes were red and watery, and her she had drastic mood swings from calm, to erratic, violent, and hysterical crying. Robinson volunteered to step out of her vehicle, and spoke to me for almost ten minutes without me interrupting her, at which time, she repeated her self multiple times. While Robinson was speaking with me, she was unsteady on her feet, and swayed back and forth greater than two inches. Robinson made statements that she was drunk, had been drinking, and was aware that she was not supposed to be driving. Robinson apologized multiple times for driving drunk, and stated over and over again that she knew it was wrong. Although Robinson had a lisp, I observed that her speech was slurred, thick, erratic in volume, and at times difficult to understand. Robinson had trouble following instructions and paying attention.

ODORS:

Obvious odor of an unidentified alcoholic beverage, which intensified as they spoke



Other Observations:

After speaking with Robinson by her vehicle, I asked her if she wore glasses or contacts. She stated that she did not. I asked Robinson if she could see the stimulus I was using, and she identified my pen light correctly as being red. I instructed Robinson to touch the tip of the pen light with her right pointer finger, and then attempted to demonstrate it for her. Robinson reached out and attempted to touch the light before being instructed, even after being told not to start until instructed. I demonstrated the task for Robinson, and she touched the tip of the pen light with the base of her pointer finger.

WALK & TURN:

I conducted HGN on Robinson, and she had trouble following instructions, and failed to keep her head still after multiple repeated instructions. Robinson finally allowed me to conduct HGN, and showed obvious signs of impairment. Upon completion of the HGN task, I attempted to explain the Walk and Turn task to Robinson. Robinson immediately attempted to complete the task, and was instructed multiple times to stay in the starting position. Robinson had to be instructed multiple times as to how to get into the starting position, even after I demonstrated it. She constantly interrupted my instruction of the task, and could not stay in the starting position without falling over. Once I was able to explain the task to Robinson, and demonstrate it, she was instructed to begin. During the first half of the task, Robinson did not count out loud, and had to be reminded to do so. While attempting the task, Robinson stepped off the line, missed heel to toe, swayed to one side, swayed from side to side greater than two inches, and took large steps, and did so multiple times. Robinson was able to count out loud on the way back, but had to ask for some of the instructions to be repeated. On the nine steps back, Robinson continued to step off the line, miss heel to toe, sway from side to side greater than two inches, and took large steps. Robinson had to hold tight to her sides for balance.

ONE LEG STAND:

Upon completion of the Walk and Turn task, Robinson was instructed on how to complete the One Leg Stand Task. While in the instruction phase, Robinson interrupted me multiple times, and swayed from side to side, greater than two inches. Once I finished explaining and demonstrating the task, Robinson was asked to attempt it. Robinson did not count out loud, and swayed from side to side, greater than two inches. Robinson also got distracted during the task, and began talking about other topics. Robinson was given a second chance to attempt the task, but was unable to raise her foot for more than a few seconds without having to put it down, and lean to one side. Robinson put her foot down and stopped attempting the task before being instructed to do so.

FINGER TO NOSE:

Upon completion of the One Leg Stand task, Robinson was instructed on how to conduct the Finger To Nose task. Robinson stated that she understood the instructions, and I demonstrated the task. When Robinson was instructed to attempt the task, the order I used was L,R,L,R,R,L. While Robinson's eyes were closed, she swayed from side to side greater than two inches. On each instruction per side, Robinson missed the tip of her nose with her finger, and touched the bottom of her nose, the upper part of her lip, her cheek, and missed her nose all together. Each time Robinson eventually made contact with her nose, her movements were slow and lethargic, and she kept her finger on her nose for more than a few seconds.

ROMBERG ALPHABET:

Upon completion of the Finger to Nose task, Robinson was instructed on how to conduct the Romberg Alphabet. Robinson eventually stated that she understood the instructions, but first she kept trying to inform me that she could not recite the alphabet backwards. I informed Robinson multiple times that I was not requesting that she recite the alphabet backwards, but was instead asking if she could recite it forwards. Robinson eventually understood the instructions and recited the alphabet in order. While reciting the alphabet, Robinson swayed from side to side greater than two inches.


